Payments

1. Payments should be done within **24-48 hrs** upon being notified to or after I accept your commission.
2. **Full** or **partial payments** are required before I begin working on **any** commissions.

- a. Payment plans are up for discussion for any orders above 200 USD.
3. You are allowed to hold a payment for **3-5 days** or **longer** if you can provide a proper reason. But if you continuously delay the payment over a long period of time, I will **cancel** your order completely and you will be temporarily blacklisted.
4. Payments via **Wise or Stripe** are preferred, all payments should only be made in **USDs**, unless stated otherwise.

Refund Policy

1. I reserve **rights** to issue a refund for any given reason at any time.
2. Refunds may be **requested** or discussed between artist and client if needed.
3. **Full refunds** are only **allowed** if I have not started working on the commission at all. Refunds are **not available** once I have completed the line art, unless given a proper reason and situation.

Commissions, Art Trades

* **note:** Please note that all my commissions, art trades, or arts made for you for a project/chorus are all for **personal usage** only unless stated otherwise.

1. Please **avoid** re-uploading any **high quality** or **full sized art works** of mine without a watermark, this is to **avoid any** theft, heavy referencing, tracing or misuse of my art and design. This is not a must but would be highly appreciated.
2. Please credit me whenever you're using, sharing or re-uploading any of my artworks on other social media or websites.
3. I reserve the right to **decline** any commissions or trades that I feel are out of my comfort zone or cannot comply with my schedule.
4. Please make sure to check thoroughly and confirm the sketch, drafts or WIPs I've sent so that we can proceed with the commission without any issues, any major changes after completion of lineart will cost additionally.
5. I **do not** consent to using any of my artworks or commissioned works to be put up as NFTs or AI learning.

Adoptables/Designs

* **note:** by violating any terms regarding my adopt/designs TOS will put you to be temporarily or permanently blacklisted from buying any of designs.

1. All adoptables/designs sales are for **personal usage** only unless stated otherwise. Using my designs commercially without my permission will lead to permanent blacklisting. I do not consent to any of my designs or artworks being minted as NFTs or AI learning.

2. Do **not** resell, trade, or gift any of my designs away outside of toyhou.se **without** notifying me in advance or at least after.
 - a. This is to avoid having any of my artworks and designs sold to anyone who has been **blacklisted**.
 - b. It's not necessary to notify me if you have it on TH.
 - i. As far as I am aware, none of the blacklisted people are on TH at the moment.
3. **No refunds**. Please be responsible for your own spendings.
4. Do **not** resell any designs you have gotten for free, in trades, or from OTAs where you did not spend anything on.
 - a. An exception is if and only if you have brought commissioned art of said design.
 - b. You're not allowed to resell any adopts you've purchased for higher than the total you've spent either.
(Original price paid for adopt + paid commissioned works only, PERSONAL or gifted art does not add to the price.)
This is to avoid people drawing additional art works in an attempt to increase the value of the adopted design.
5. I retain **partial rights** to all of my arts and designs. In cases of misuse, chargebacks or violating my TOS, I am allowed to reclaim my designs. Failure to elaborate the situation will lead to permanent blacklisting.
6. Do not make any of my designs or concepts into your own closed species. You are not obligated to keep them in the settings or canons I've presented them in the closed species. Feel free to take them out of it.
7. Please **credit** if you're using, re-uploading any of my designs or art works on any social media, if you're uploading the character onto

toyhou.se please credit [yukiflake](#) as the creator, i would love to read what you've done to the designs!

8. Do **not** claim any designs I've made as yours unless it was a MYO! Also do not make any of my unfinished WIPs into your own original characters.
9. Co-ownerships are **not officially allowed** or recognised on my masterlist. If there's any problems between both owners, you're expected to deal with it between yourselves. Co-own any design **at your own risk**.

Bidding Rules

1. Please **always** bid in a chain/reply to the highest bidder.
2. Bid **only when** you have the exact amount of money in hand.
3. Do **not** harass, beg, advertise, whine, disturb or behave rudely to others on my posts. You will be warned for the first offence, repeated offense will result in **permanent blacklist** and **blocked**.

Design Modifications

1. Please **do not do any major** modifications on my art or the original designs, if any modifications of the character design is to be made, please do so **separately**!

2. Only **minor** modifications such as adding a piercing is allowed to be added onto the original art but please **keep** the original file when you're going to rehome the design in the future.
3. Modification of the **clothing** colour palettes are always allowed, dress them up however you like! But modification of the physical appearance is strictly not allowed **without prior notification**. Please make sure you follow the rarity traits if they're a part of a species.
4. Most modifications on the design are allowed as long as it can still be **recognised** as the original.
5. In cases of reselling or rehoming, the original design must be presented and given to the new owner as they're supposedly the original design. However, you're not allowed to modify the character and resell the old design to the said character whilst keeping the new one.
