INTRODUCTION

Manuscripts are typed in 1 (one) space using Ms. Word (**Cambrian font, size 10 pitches**), with a minimum word count of ± 4500 words or 6 – 10 pages of A4 paper (includes pictures, tables, illustrations, and bibliography), page setup for margin, left = 0.98", right = 0.98", Bottom = 0.98", and Top = 1.18"

The introductory section contains the background (must be cited/quoted from previous journals/previous research), research context, methods used, results of literature review, research novelty, and research objectives. **Use MENDELEY Tools to CITATION**. The entire introduction is presented in an integrated manner in the form of paragraphs, with a length of 15-20% of the total length of the article.

References cited or quoted using the author-date rule only include the author's last name and year of writing (example: Kotler, 2020)

and please double-check using the Mendeley facility.

MATERIALS AND METHODS

The method section contains an explanation in the form of paragraphs about research design, data sources, datasets, data collection techniques, and data analysis that is carried out by researchers, with a length of 10-15% of the total length of the article. **No need to Displaying THEORETICAL**.

RESULTS AND DISCUSSION

The research results **section contains an explanation of the results of the analysis related to the research question. Any research results should be discussed. The discussion contains the meaning of the results and comparisons with theories and/or similar research results.** The length of the result and discussion is 40-60% of the length of the article

If you are presenting a table, you must mention state the name of the table.

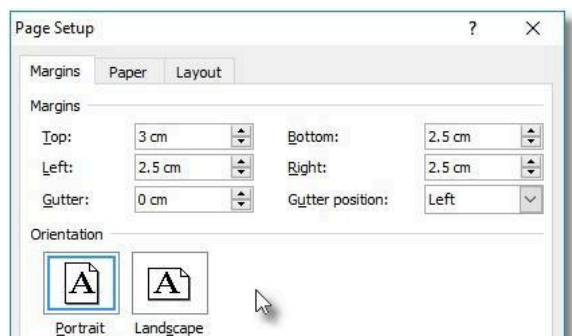


Figure 1. Page Setup window

Naming tables or figures **NOT ALLOWED** use numbers from chapters, such as **Table H-1** or **Table 2-1**, and the like. Similarly, images not allowed, like this: **Figure 2-1**. Image Name, or **Figure H-2**, and the like. If you present an image, you must state the name of the image and state the source of the image, for example in Figure 1:

Submission

You are not allowed to submit manuscripts in PDF format, they must be in DOC/DOCX format

CONCLUSION

The conclusion section contains research findings in the form of answers to research questions or the form of a summary of the results of the discussion. **Conclusions are not allowed to repeat discussing problems or theoretical definitions.** Conclusions are presented in the form of paragraphs. Not presented in the form of points or numbering

REFERENCE

The reference list contains only the sources that are referenced and all the sources referenced must be listed in the reference list. **The minimum number**

of references used is 15 journal papers/proceedings. Reference sources at least 80% in the form of libraries published in the last 5 years. The references used are primary sources in the form of research articles in journals or research reports (including theses, theses, dissertations). Minimize the use of books. Articles published in TECHNO are recommended to be used as references.

- **No need to be grouped by** books, journals, newspapers, or by other types of publications.
- **Using the style of APA edition 6** (American Psychological Association)
