 - b) LC working on updates to Indians of North America and tribal headings, will do less with jurisdictional headings; LC's Modern MARC is doing less with faceted subject headings
 - Getty trying to lower barriers for submission to Getty vocabularies; Getty is contactable and does updates 1x/month
