- 1. Commitment:**
- 6.1. AWARE Group will provide all elements of the AWARE Programs.
 - 6.2. AWARE Group will provide tools and information for the program. AWARE is a self directed option designed to facilitate the creation and development of personal, professional, or business goals.
 - 6.3. A private Facebook Forum is available for questions if you would like to share a success, have questions or an issue.
- 2. Your Commitment:**

As a member you are not permitted to duplicate, share, or copy to any unauthorised people or organisations outside the membership of the AWARE Group. Any breaches of this condition may result in the cancellation of the participants membership and/or financial restitution for loss of income and/or breach of this agreement.
- 4. Your Agenda:**
- 4.1 The Membership agenda belongs to You. The pace and competition of your program is in your control. We suggest you make a regular time and commit to the process in order to benefit from the design and products.
 - 4.2 All communications on the Facebook Private Group Page must adhere to the AWARE Group code of practice as set out on the Facebook page.
