 - California Coastal Commission 8/2/24 Letter Re: BESS
 - The California Coastal Commission issued a letter on 8/2/24
 - Proposed site
 - May be ESHA
 - It is in a Coastal Hazard Zone (sea level rise and tsunamis)
 - Cannot build revetments because it is new construction and not coastal dependent

- Supervisor Paulding and Supervisor Gibson have established a task force to deal with fireworks
 - Will meet in September to come up with a countywide enforcement strategy

 - Seeing a trend with a rash of scams starting with a "pop up" window that your security has been compromised; They say they are Microsoft
 - Convince the victim to withdraw cash and send a courier to your home with a "code" word.
 - Call the Sheriff's Office
 - They may be able to work with you so that they can take someone into custody
 - Always go to a published number
 - Be aware that scams can "spoof" real telephone numbers

- Graffiti is stylistic vs. gang graffiti
 - Sheriff's Auxiliary Volunteer Coordinator will connect with Vicki Tamoush to remove the graffiti and/or train/equip local volunteers
 - Needs to be removed quickly to prevent new graffiti
- Private Ownership of Beach
 - Sheriff's will work with Code Enforcement and State Parks
 - Some is State Parks and Some is County
 - Could work on getting signs at entries

 - Will resemble southern part of the sea wall
 - Grants could speed up the timeline
- Subcommittee on Fireworks
 - Will meet with admin, Sheriff's Department and Cal Fire
 - Will meet in September
- Driftwood Removal
 - Supervisor Gibson met with the California Coastal Commission regarding driftwood
 - Parks will get a long term permit that will allow them to use mechanized equipment to move the driftwood
 - Greg Bettencourt
 - Thank you Bruce Gibson for getting rid of the driftwood
- Greg Bettencourt
 - Regarding the Beach Wall
 - New repaired piece would look like the southern existing piece without any places for people to sit
 - That is not acceptable
 - Changes the nature of the wall
 - We would no longer have seats
 - We need to have the seats for families to sit on
 - We need to be involved in August, 2024
 - Bruce Gibson agrees with Greg Bettencourt
- Thomas Sooter
 - Neighbor wants to know about political signs
 - Are there regulations on sign size?
 - Blake Fixler will get the ordinance

General Plan Amendment--Property Across from School

- General Plan Amendment to change from Commercial Service to Residential Multi-Family–Unanimous on this part
- Applicant showed potential projects, but this is not part of the amendment
 - Up to 8 units multi-family residential
 - How to measure the height
 - County wants to measure from midline of the Birch
 - Almost all are average natural grade
 - Land Use wants to continue using average natural grade
 - Since it is next to a school—look at line of sight from the apartments to protect from potential shooters
 - Two Units facing the Single family with ADU
 - o Parking would be to code
- Motion: Steve Beightler
 - To support the land use change from Commercial Services to Multi-Family Residential from Ash to Birch. The Birch parcel shall be no more than 8 units and the height will be determined from average natural grade. When considering the minor use permit, line of sight to the school shall be considered.
