

98c Learning Loss Grant/Plan- Update Spring 2023

This funding is part of the Secondary School Emergency Relief (ESSER) II Fund and the Governor's Emergency Education Relief (GEER) Fund. The funds support goal 5 of Michigan's Top 10 Strategic Education Plan. Funds are to target accelerated instruction to address learning loss. This application will outline the requirements of 98c, address the purpose of the funds, and outline funding under this grant.

Literacy Plan

Based on the analysis of student data over the last two years, it has been determined that there is a gap between K-3 literacy skills and the current level at which students are performing, as well as a gap between K-8 literacy skills and the performance level of students in the following demographic groups: Special Education, English Language Learners, Economically Disadvantaged, and Black or African American. The disrupted learning over the last three years have created learning gaps for students. Our plan is designed to support teachers in professional learning and student programs to meet students' instructional needs.

Literacy End-of-Year Goal

- 75% of K & 1st Grade students will demonstrate expected growth and 85% will demonstrate proficiency as measured by NWEA Reading Fluency.
- 75% of 2nd-8th Grade students will demonstrate expected growth and 75% will achieve in the 60th percentile or above as measured by NWEA MAP Growth.

The disrupted learning over the last three years have created learning gaps for students. Our plan is designed to support teachers in professional learning and student programs to meet students' instructional needs.

• 75% of K-8th Grade students will demonstrate expected growth and 75% will achieve in the 60th percentile or above as measured by NWEA MAP Growth.
