

Privacy Policy for User

[Three Days Recreation](“we”, “us”, or “our”) is committed to ensure that all personal data submitted through the [Golden Tree](“App” or “Service”) are handled in accordance with the relevant privacy data laws. This Privacy Policy for User explains how we use, store and share the information we collect about you.

Changes

This Policy is subject to change; therefore, we encourage you to review it frequently for any revisions or amendments. Privacy changes we post on this page are effective immediately and you accept the changes by continuing to use our Services.

What personal data will we collect about you?

Personal data means any information that relates to an identified or identifiable individual. The personal data we collect includes:

- a)device identifiers (such as IDFA, IDFA for Android, GAID for IOS).
- b)email address.
- c)the type and operator of network (such as Mac address).
- d)the type, version, brand, language and operating system of device.
- e)behavioral usage of the App.

How do we use your personal data?

Generally, we use personal data for business purposes, such as to:

- a)Provide you with access to and use of the App.
- b)Perform business operations, including the improvement of the App, conduct surveys, research, and data analytics, and other normal business activities.
- c)Respond to governmental and other legal requests or to comply with applicable laws.

Sharing your personal data

We will only disclose your personal data to:

- a)Companies within our group.
- b)Third party suppliers, business partners and sub-contractors for business administration, support, processing, services, or IT purposes.
- c)Our professional advisors (including without limitation, tax, legal or other corporate advisors who provide professional services to us).
- d)Other bodies or agencies to comply with our legal and regulatory obligations.

Protection measures

We have in place appropriate policies, rules, and technical and organisational measures to protect your personal data from unauthorised or unlawful processing, and against accidental loss, destruction or damage. We also have procedures in place to deal with any data security breach. We will notify you and any applicable regulator of a data security breach where we are legally required to do so.

How long will we keep your personal data?

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements. We may delete or anonymise your personal data (so that it can no longer be associated with you) after we no longer need to retain your personal data.

Children's privacy

The Services are not intended for children under the age of 13 and we do not knowingly collect, share for targeted advertising, or sell personal information from children under the age of 13. If we become aware that we have inadvertently received personal information from a child under the age of 13, we will delete such information from our records.

Your rights

You have the right to:

- a) Be informed about the personal data we hold about you.
- b) Access the personal data we hold about you.
- c) Rectify any inaccurate personal data we hold about you.
- d) Delete the personal data we hold about you.
- e) Receive the personal data you have given us, in a structured, commonly used and machine readable format.
- f) Withdraw your consent, where we are relying on it to use your personal data.
