### THE ART OF CARE-GIVING: A new "life stage" (\*)

Jewish community aging. Best guess, @25% of American Jewish community 65+. Fastest growth: 85+. Living longer, better, but when health issues arise they are often more serious and require increased care. New "life stage" that can often last not months, but years and even decades.

\* According to the World Health Organization, the percentage of the world's population over 60 will nearly double by 2050, rising to 22 % from 12%. In the USA, the census bureau projects that by 2035, people 65 and older will outnumber people 18 and under for the first time." (NYTimes. 4/23/19)

#### SOME RANDOM STATISTICS ON CARE-GIVING

- a. More than 50 million people provide care for a chronically ill or disabled family member or friend during any given year...47% experience financial challenges as a result...6 in 10 work full or part time...24% care for two or more people...more than ½ of US labor force has caregiving responsibilities and @ 37 million Americans can spend nearly 4 hours a day looking after an elder...avg out of pocket expense per year @ \$7,200
- b. The typical care-giver is a woman, about 50, caring for her widowed mother who does not live with her. She is married and employed. Most care-givers are women. About ¼ of all caregivers are now between 18 and 34. Gender bias? Economic impact of this juggling? Legislation to compensate, provide safety net for time spent as care-giver?
  - Rise in male caregivers. AARP: 40% caregivers are now men up from 34% in 2010..men are slightly younger and provide slightly less care than female caregivers, but do similar things.
- c. 30% of family caregivers caring for older adult are themselves 65+.

  Longevity revolution...living longer. Now, @1/4 of adults caring for elders are between 18 and 34...implications for Millennials? (AARP and Nat'l Alliance of Caregiving)..... Challenge as well for caring for adult children with disabilities.

  THE CLUB SANDWICH GENERATION!
- d. Potential generational storm emerging as Baby Boomers (1<sup>st</sup> wave now 65-70) file for Social Security and Medicare. Creating stress on these programs. Likewise, as Boomers age and live longer, realization that not enough qualified care-givers/gerontologists to meet expected demands.

Worker-retiree ratio declined from post WW 2 (7:1) to now, about 3:1. ...within next decade we will need at least 1.8 million additional home care workers...by 2018 demand for these workers will increase by more than 90%...legislation to provide tax credits for care-givers? (CARE act)

Also, by 2030...% of non-working citizens who rely on working people to Pay into Social Security/medicare will exceed 70%. Many Boomers don't Have enough saved to fund 20+ years of retirement. (The Week. Aug. 23, 2019)...."45% of Boomers have no retirement savings and more than a quarter of those who do have less than "\$100.000.00)"

- e. Expected growth as well in Alzheimer's cases from 5 million now to @ 15 million in next few decades as Boomers age out...again, who cares for us and who pays? Current costs for Alzheimer's/dementia= @ \$226B p/y increasing research and delaying onset by 5 years could cut the # of people getting these in ½. ("Changing the Trajectory of Alzheimer's/Dementia: How A Treatment by 2025 Saves Lives and Dollars") (see also <a href="https://www.growingolder.net">www.growingolder.net</a> for spiritual support for individuals and families dealing with Alzheimer's)
- f. Care-giving tsunami makes it possible that in next few decades elder care issues will replace child care issues as major family concern....longevity revolution now has (as of 2015) @ 7%, some 3 million plus, people over 75 years of age active care-givers helping with activities of daily living (bathing, dressing, toileting), instrumental activities (shopping, transport, health care system) as well as increase medical and nursing tasks.
- g. Care-giver "burnout" responsible for economic, emotional and spiritual stresses and strains. Increased mental health fallout and family systems tensions. (see: "Anger May Fade to Sadness As Caregiving Ends". Aarp.org. 4/2/19)
- h. Now, more people 60+ than 15 and below. Every 8 seconds someone turns 65...@ 10.000 per day...70% of people 65+ need some support . By 2050 # of people 65+ expected to grow from 43 million (2012) to 84 million
- i. Economics of aging...THE social justice issue for next few decades?

  Average nursing home costs, 2015=@ \$80K p/y; basic assisted living
  @ \$3K p/m...add to that home health workers....and morality of having to
  "spend down" assets to qualify to Medicaid. Add to this, a growing sense of
  of Income Inequality as Boomers Age within Boomer cohort and between
  Boomers and our children. Who pays for our care? Who will take care of
  Us? (see Jewish Sacred Aging/Facebook post from NextAvenue.org Oct.
  16,2019 "The Distressing Growth of Wealth Inequality of Boomers")

*Honor:* helping parents eat and drink, clothe and cover them, and helping them go in and out.

\*honor and respect are deeds..actions not feelings..,love???????

- \*ceding care to third party?......parent---my family/self?

  Danger to parent/others (Alzheimer's/dementia?)

  sakanot n'fashot and p'kuach nefesh
- \* Adult child should care for parent, BUT, if it becomes impossible due to change in parent or negative impact on family, or threat to parent or others...permissible to cede care to third party (Maimonides: Hilchot Mamrim 6:10)

- 1. What are your biggest fears and concerns?
- 2, What goals are most important to you?
