ADVERTISING AND AUTOMATICALLY COLLECTED INFORMATION

Google Admob: The free version of our app includes some ads displayed with Google Admob. Admob need internet permission to show ads. It may collect some device information. We do not use any kind of user information or save it.

Facebook Audience Network: The free version of our app includes some ads displayed on Facebook Audience Network. Audience Network needs internet permission to show ads. It may collect some device information. We do not use any kind of user information or save it.

COLLECTION AND USE OF PERSONAL INFORMATION
