Overview

Our camp community is designed to be inclusive and available to everyone, and especially working families.

Over the years, we've developed great relationships with our Camp Families, and the companies where they work, partnering with dozens of local, regional, national, and international organizations to provide additional savings.

Parents who are employees of organizations participating in our Workforce Discount Program receive an additional **savings of \$20 per week enrolled, up to \$160 savings per Camper**, when they enroll and upload proof of employment to their camp account. Proof of employment includes a letter on company letterhead, a current pay stub and/or an ID badge.

Terms and Conditions

Applicability

Discount is applicable once per qualifying Camper per camp season. Proof of employment is required in the form of a letter on company letterhead, a current pay stub and/or an ID badge. You must submit proof of employment no later than 10 business days after you submit your child's Camper Application for the discount to be applied.

Timeliness of Discount Submissions

Discounts are not applicable for late submissions. Submission date is calculated for online applications as the date the form is submitted.

Custodial Families or Legal Guardians

Discount is applicable only for Campers whose Custodial Parent or Legal Guardian (must be listed on the Camper's application) is actively employed by a participating organization at the time of enrollment (active duty service members, Military Retirees, and Veterans qualify for the discount with valid military ID). Proof of employment is required every camp season.

Participation Requirements

Discounts for the 2025 camp season are applicable for Camper applications submitted on or before April 1, 2025. At least 5 Campers from the participating organization must be enrolled by April 1, 2025 for discounts to apply. Late enrollments may be considered for the discount with proof of employment submitted within 10 days of the enrollment date.
