Discuss Your Counseling Licensure. (i.e. courses/exam, # of hours, state or multi-state licensure):

- Have to be a lifelong learner. You are required to complete CEUs each year. HN
- In Maryland- During school, must complete an internship and complete 1,000 hours of clinical work. At Least 50 have to be with a board certified supervisor. LG- [Licensed Graduate Professional Counselor](#). Renewal is every 2 years. AI
- DC- graduate with a MSW, which you can work with. Talk to your employers to ask if they will pay for some of the fees if you are working and pushing for a licensure. SS
- I am always learning and checking in with others to stay up to date.

What career position (s) does your Counseling Licensure qualify one for?

- Self employed working with personality disorders as well as a clinical supervisor. I also work in a mobile crisis center. I am trained in [EMDR](#). My program in Christian Counseling prepared me for the certifications and licensure. In my clinic I do not include spirituality unless the client requests it. AI
- As an LCC we see it all. A counseling mental health center would be the best place to start. I started with in-home counseling centers. Currently, I work for a managed care company and it is not widely known. Consider looking into healthcare or medical care to get started. SF

Positions for BA/BS students?

You can't do counseling directly with a bachelor degree only, but the positions below offer insight into what the field might be like to work in.

- Psychiatric rehabilitation centers would offer entry level positions.
- Consider looking at non-profits to find positions working with the population you are interested in working with.
- In DC, the charter schools will hire professionals with a LGSW.
- Bachelor level job titles: Peer recovery specialist, phone crisis counselor positions, peer mentor, mental health tech, case manager (state or a non-profit), ABA therapist, view more options from [UMD BA/BA graduates](#).
- I took a year off and worked in a call center before I decided what I wanted to do. Take your time to figure your path out. There is no rush! AI

Clinical vs counseling?

- My masters is in counseling and it is very versatile. I work with cognitive behavioral therapy. Tele-mental health is an option. HW



Multi-state licensure/Endorsement? Endorsement- states have an agreement to allow you to practice in their state if your current standing is good. If you are interested in multi-state, find out which one is the most difficult, get that one first and then you can apply for the other states. FYI- DC is a little difficult.

Can you get multiple licensure? Yes- you just have to pay for them! I have to pay for VA, DC, EMDR, trama, Tele-health. AI

Graduate school: Degrees, etc.

- Masters level- you can not practice with a masters in psychology.
- PsyD- more client based.
- PhD- more researched based.
- **Licensure is not always worked into the program.** It depends on the program and their relationship with the governing board in that state.
- Look for programs and schools that are accredited! Choose from the [CACREP accredited programs](#).
- MSW- you can take the LGSW exam 3 months before you graduate, but you do not have to have a license for all jobs.
 - 1. LG, Licensed Graduate (completed graduate school and completed the license)
 - 2. 100 hours of supervision and 3,000 hours (2 years) of clinic
 - 3. Then you can sit for the Independent licensure exam
- When do you start seeing clients in graduate school?
 - During my practicum as well as volunteering. HW
 - During my practicum- it was 500 hours, in my second year. That was followed by a 1,000 hour internship. It is under supervision. SF

Advice:

- Jobs: References and relationships matter. SS
- Develop skills like communication, helping skills through internships so that you can demonstrate skills on your resume for your next opportunity.
- This field requires professionals who are lifelong learners. You are required to complete CEUs each year.
