Job Summary:

The School Secure Entrance Monitor at the high school plays a crucial role in maintaining a safe and secure environment for students, staff, and visitors. This position is responsible for controlling access into the school building during the instructional day, monitoring activity at the entrance, enforcing safety protocols, and responding to emergencies as needed.

SECTION II: ESSENTIAL DUTIES AND RESPONSIBILITIES

- Access Control:
 - Monitor and control all entries and exits to the school building.
 - Verify the identity of individuals entering the school, including students, staff, parents, and visitors.
 - o Ensure all visitors check in and out according to school policy and are issued appropriate identification badges.
 - o Prevent unauthorized individuals from entering the school building.
- Monitoring and Surveillance:
