The article should be written single-spaced, Cambria, font size 11. The article has to be written in 3,000 to 10,000 words, excluding the abstract and references. The file must be saved as .doc/.docx or .rtf file.

The introduction provides background information on the study. The author(s) must describe the reasons why the topic being examined is worth studying. References to the topic should be supplied, preferably from international journals.

At the end of the introduction section, the author(s) must underline how the current study differs from past studies and present the research gap it fills. The study objective(s) should be expressed explicitly in this section.

Organization and citation are written in American Psychological Association 7th Edition (Agus, 2021). The non-English terms are written italic (italic).

The authors also must explain the data collection and data analysis. The description of the course of research should be supported by references, so the explanation can be accepted scientifically.

RESULTS AND DISCUSSION (Cambria 12, Bold, Center)

In this section, it is explained the results of research and at the same time is given the comprehensive discussion. Results can be presented in figures, graphs, tables and others that make the reader understand easily. The discussion can be made in several sub-sections.

One spaced, 11-point Cambria, excluding references and appendices. Use indent for the first paragraphs and do not leave a space between paragraphs. The following paragraphs is indented first line 0.75cm.

Sub-heading 1 (Cambria 12, Bold, Italic)

Author can use sub-headings to divide the findings and discussion into parts. The sub-heading is in bold and italic.

Sub-heading 2 (Cambria 12, Bold, Italic)

Author can use sub-headings to divide the findings and discussion into parts. The sub-heading is in bold and italic.

CONCLUSION

This section marks the paper's conclusion. Concisely describe the responses to research problems or findings that are relevant to the objectives. Do not repeat the sentences used in the findings and discussion sections. The author may also advise future researchers to develop the paper.

When needed, the author(s) can offer acknowledgment to people or institutions who have helped or granted the article.




Figure 1. The Example of an Image (Center, Cambria, 11)
