# **Privacy Policy**

The Privacy Policy is closely related to your privacy. SPINZ Co. #### Collection of Information

Generally we will collect your Information directly from you, but in some circumstances, it may be necessary for us to collect information from a third party source. Specifically, your following information may be collected and used by us: (a)device information, such as Mac address, IDFA, IDFV, GAID, device model, device brand, device language, device network type, screen resolution, etc; (b) log information, such as the time/date you use the App, etc; (c) email address (collected only if you actively provide it to us or contact us).

## Reasons for Collecting Information

# Sharing of Information

- 1. Third Party Service Providers. We may share your personal information with third party service providers who perform various functions to enable us to provide our services and help us operate our business, such as fraud detection and prevention, customer care, or performing analytics. - 2.Response to Subpoenas and Other Legal Requests. #### Protection of Information

We have put in place appropriate technical and organizational security measures to prevent your information from being accidentally lost, used, accessed in an unauthorized way, altered, or disclosed. In addition, we limit access to your information to those employees, agents, contractors and other third parties who have a business need to know and are subject to a duty of confidentiality. They will only process your information on our instructions.
