## 1. What Data Do We Collect About You?

We shall collect and use your personal data only for the purposes stated in this Privacy Statement. Personal data refers to any data that enables us to identify you as a user.

For the purposes of communicating with you and administrating the Activities when you participate in the Activities, it is necessary for Honor to collect the following personal data from you: **name**, **title**, **contact details** (**including phone number**, **email address**), **correspondence address**, **photo**, and **video**.

### 2. How Do We Use Your Data?

We will only process and use your personal data for the purposes of communicating with you and administrating the Activities by Honor.

# 3. How Long Do We Store Your Data?

- (1) All your personal data related to the Activities will be stored in Malaysia.
- (2) We retain your personal data for up to a maximum of 12 months from the end date of the Activities. Once the retention period expires, we will delete or anonymize your personal data, unless otherwise required by the applicable laws and regulations.

### 4. How Do We Share Your Data?

We will use your personal data for the following purposes with your consent:

#### Marketing:

- (1) We use your personal data including name, title, contact details (including phone number, email address), correspondence address, photo, and video for the purposes of communicating with you and administrating the Activities by Honor.
- (2) With your consent or unless you object, we may use your email and/or phone number and cookie data for marketing purposes, including inviting you to complete customer satisfaction surveys and feedback questionnaires.

We may share your data in the following circumstances:

• Our third-party suppliers located in Malaysia, who provide us with IT (including cloud-based) services, business support, and customer services, may need to process your data. These third parties are operating under contract and acting on behalf of us.
