#### Financial Report: (Tom)

- Income: Already have \$103K (budget for the whole year was \$102K),
- Expenses: \$101K, \$117K was budgeted. Surplus of \$2,600 based on the estimated loss of \$15,000!
- Grounds were \$7K under budget
- Administration \$10K under budget (primarily due to the fact that we did not proceed with the covenant rewrite
- Pool \$2K under, trash \$2K over
- \$29K in cash (only \$21K budgeted)
- \$13K still outstanding, mostly unpaid dues (approx. half of that is from one household)
- Next year potential to pay via Credit Card, Venmo, Direct Debit Tom has it under investigation
- '24 income projected at \$102,893
- '24 expenses projected at \$113,746
- Estimated loss of \$10,854 in '24, with beginning \$ of \$29,453 end of '24 projected at \$20,599 cash in hand
- Board votes to increase dues by \$70/ year/household
