1.Information we collect

We collect the following information about you from you and other sources:

device identifiers (such as IDFA, IDFV for Android, GAID for IOS).

behavioral usage of the App.

email address.

the type and operator of network (such as Mac address).

the type, version, brand, language and operating system of device.

2.How we use the information

We use and in specific cases combine the information we collect to operate, tailor content, personalize, adjust, and improve our App, and to send you messages or personalized information about our App, new features and more, including for marketing and promotional purposes. In addition, we use your information to operate our business, including analyzing our performance, meeting our legal obligations.

3.Your choices

You have following choices over the information provided by you:

Access, correction to or deletion of your information.

Object to processing of your personal information.

Ask us to restrict processing of your personal information.

Request portability of your personal information.

If we have collected your personal information with your consent, you can withdraw your consent at any time.

4.Children and parents
