We may collect the following information:

Employer and occupation (as required by election law for certain contributions)

Payment information (processed securely by third-party payment processors)

B. Automatically Collected Information

Browser/device information

Cookies and tracking data

Source of opt-in

We use your information to:

Send political and fundraising communications

Process donations

Comply with federal and state campaign finance laws

Maintain records of consent

Improve campaign outreach

Respond to inquiries

Law requires us to use our best efforts to collect and report the name, mailing address, occupation, and employer of individuals whose contributions exceed \$200 in an election cycle.

By making a contribution, you confirm that:

You are a U.S. citizen or lawfully admitted permanent resident.

This contribution is made from your own funds.

You are not a federal contractor (if applicable).

You are at least 18 years old.

You may opt out at any time by replying:

STOP

You will receive a confirmation message, and no further messages will be sent unless you re-subscribe.
