

Wedding Photography Contract of Services

Both parties must agree to all Terms & Conditions to complete booking.

This agreement, dated today, between the clients and between Selina Kozub, hereinafter referred to as "The Photographer", and 1st couple and 2nd couple, hereinafter referred to as "The Couple", agree as follows:

The Couple shall engage the services of The Photographer, for a elopement photos on the agreed date in 2021 at the agreed upon time and location.

The Photographer shall execute one hour of photography services, including coverage of the legal marriage ceremony for The Couple, for the fee of \$315 (\$300 + GST). A non-refundable deposit is required at the signing of this contract to reserve a date and time and to commence the work. The contract balance must be paid within 7 days prior to the date for the ceremony to commence.

Upgrades and Travel would be additional charges.

The Photographer will arrive prior to the scheduled ceremony time, and departs after the completion of the one hour. The Photographer will dress appropriately.

In the event that The Photographer is unable to perform the photography due to an unforeseeable cause, she will make every possible arrangement to have another Photographer perform the ceremony, and will still edit and return the images as agreed upon. If the services are not performed, The Couple will receive a full refund of all pre-paid services. If The Couple cancels services the deposit will not be returned. Cancellations within 14 calendar days of the wedding date require payment of the full contract.

Image return time may be effected by the Photographers work load. The Client shall assist and cooperate with the Photographer in obtaining the desired photographs, including but not limited to specifying persons and/or scenes to be photographed; taking time to pose for photographs at the Photographer's direction; providing a person to guide the Photographer to desired persons and/or scenes; pre-shoot consultations, etc. The Photographer retains the right to cancel a shoot at anytime if a client fails to communicate effectively. The Photographer shall not be responsible for photographs not taken as a result of the Client's failure to provide reasonable assistance or cooperation, or weather conditions. Travel fees may apply. The Photographer retains copyright in the photographs, and hereby grants the Client unlimited but non-exclusive rights to use or reproduce the photographs for which the Client pays. Applicable Law - This contract shall be governed by the laws of the County of Canada in the Province of British Columbia and any applicable Federal law.

The Couple may use photographs or recordings of The Photographer for their wedding memorabilia purposes. Likewise, The Couple gives permission to The Photographer to use their likeness in photographs or recording for marketing purposes, upon the approval of The Couple.

Date Change

In the event that The Couple wishes to change the date or time of the ceremony, and The Photographer is available on the new date, The Couple will be charged a \$100 reschedule fee.

This agreement is valid for the wedding services for the place and date stated in the booking.

Choosing that you have read and agreed to the terms above is a legal electronic signature, and can be held as such in any court of law.
