In the first Trump admin, the illegal, immoral, unpresidential, and stupid stuff from the Trump administration and the parts of his family he dragged into it were countless; it was hard to even keep track of them because there was always another. As the clown car is about to be unpacked again, this document covers/will cover that stuff again.

This stuff is in-bounds:

- Official acts of Trump
- Statements by Trump
- Things said and done by members of his cabinet/administration and other prominent government roles
- Things said and done by close political proxies and the parts of his immediate family that are politically active within his political bloc

Not all of these categories are equally serious/damning, and I'm starting now, in the early stages of transition.

Covered things are not necessarily illegal; things that break norms of governance, that seem like abuses, or that are particularly harmful.

Character is part of being a President (as is controlling messaging from one's administration and political allies - expelling people who behave inappropriately is a duty); things that indicate poor character are in-bounds. I don't yet take a stance on whether Elon Musk is in-scope, but as I am not active on Twitter, I will miss a lot of his nonsense. (Update: Musk is apparently asked to be part of a special project, so he is in-scope; I can't cover him well both because his idiocies are almost as numerous as Trump's and because I left twitter about two years ago and didn't want to follow him when I was there)

Limits:

- I'm deciding to exclude the most fringe parts of the political right that are not (currently) close political proxies, like MTG or Ramaswamy; if he brings them into his administration, I'll cover them
 - Update: Ramaswamy is unfortunately named part of the administration
 - Later Update: He's back out again
- FoxNews hosts (unless they join the admin) are generally not in bounds
- I'll try to use well-sourced material for the facts of the matter (the analysis will be mine, and may extend beyond the source); I won't generally include sources, but I trust that the mix of dates and specifics will make finding good sources for anything included here pretty easy
- Dates may be inaccurate; they may be dated to when something made the news instead of when it happened.
- I will depend on mainstream media to do their job, as I generally trust journalistic ethics and that people are trying to do the right thing. If I go beyond that, I'll try to note it so people can take things accordingly
- I will not go heavy on health policy matters, because even though this and invasions Trump may start are the two most important topics, health policy matters are better

handled by someone else and a variety of doctors who talk on public health policy are doing a very good job at covering the dumb things RFK Jr is doing; beginnings of a list:

- Craig Spencer
- Andrea Love
- I will generally omit things that strike me as regular-sized scandals; the kind of errors any administration should make (even when people should be fired); just as an example, the recent use of Signal (a private chat app not vetted for security) to coordinate strikes on Houthi militants; a more responsible admin would respond by banning Signal and (at least) making everyone involved take opsec training rather than claiming it's not an issue and having some participants lie and others confirm the whole thing, but that's not the kind of issue I generally cover here (however serious it is).
- I'll largely avoid highly technical matters like national security and classification, as
 reasonable people may disagree on these matters and most people don't know much
 and won't be uniquely led to mainline professional conclusions should they start to look
 into things

I'll break things down topically and then by time (which might be time of actual event or time of news stories).

All choices of how and what to cover or not cover are based on my views; I am a technocratic liberal, not a progressive, not a moderate, not a libertarian, etc etc.

Categories may shift as certain topics emerge

Appointing the incompetent and/or unsuitable to positions of power

Whether these people make it in is important, but if they're blocked the fact that they were nominated remains a sign of extremely poor judgement that we should expect to apply to many other decisions, including those we don't see.

2024-06-15 - JD Vance as running mate. Vance has at times expressed a number of views incompatible with leading the nation, including notably that professors are "the enemy" and encouraging political attacks on them (
 https://www.youtube.com/watch?v=0FR65Cifnhw) and has been involved with the far-right Project 2025 for many years. He has advocated a variety of weird fringe

- positions, like giving parents more voting rights, replacing most civil servants with political supporters, and supporting Trump's insurrection attempt in the 2020 election.
- 2024-11-11 Lee Zeldin to lead the EPA. He tried to validate Trump's attempt to steal the last election, he criticized Hochul for (correctly) identifying climate issues as contributing to recent brush fires in the area, and he has stated that his initial efforts will be to roll back environmental regulations affecting car design, power plants, and oil/gas production; he has said his priority is on economics, which neglects that the role of the EPA is to ensure that our economic activity doesn't damage the environment more than necessary (finding a good balance is hard, but he doesn't seem interested in even trying). Policy orgs focused on the environment have ranked him extremely poorly on environmental issues, and his legislative record shows an enduring hostility to any climate concerns.
- 2024-11-12 Ramaswamy and Musk to lead a special effort to cut government spending; neither of them have any competence to do this, the former mostly being known for a number of bizarre ideas that either wouldn't work or would break with our civic norms (from invading Mexico to attack cartels to raising the voting age to 25), the latter being a snake oil salesman who has accomplished little, bragged a lot, and accused people criticising him of pedophilia. No government experience between them.
- 2024-11-12 Pete Hegseth, a Fox News host with no government experience and a number of bizarre views, to become SecDef. He apparently doubts germ theory and doesn't think women should be in most military roles, and has advocated pardons for members of the US military who committed war crimes. He has a violent ideology, with tattoos that proclaim it.
 - 2022-11-26 He's also suggested the US military should ignore the geneva conventions on war, and advocates a crusade mentality to war (he outlined this in a book - The War on Warriors)
- 2024-11-12 Elise Stefanik to become diplomat to the UN she blamed Trump's insurrectionists on Nancy Pelosi and went all-in on Trump's attempt to steal the election, supporting baseless claims by fringe media outlets about voting systems frauds, and pushing false electors
- 2024-11-13 Mike Huckabee, who supports illegal settlements and sees Israeli control of
 the entire West Bank and Gaza as desirable, is announced as diplomat to Israel.
 Unqualified diplomats are unfortunately the norm in our politics; the norm-breaking here
 is to support someone in support of the most hardline, awful policies from Israel's far
 right.
- 2024-11-13 John Ratcliffe, who served a partial term as director of national intelligence in Trump's first term and repurposed classified intelligence for political purposes, and who has no relevant experience in counterintelligence, is to lead the CIA
- 2024-11-13 Matt Gaetz for Att General, who prioritised endless investigation of political opponents over legislation for the legislative branch, was involved in sex-trafficking (and voted against funding anti-trafficking orgs), suggested violence against ANTIFA, and suggested the FBI should be defunded while it was looking into his child sex trafficking.
 He has since withdrawn from consideration after investigations began digging up embarrassing dirt and his confirmation seemed unlikely

- 2024-11-13 Tulsi Gabbard for DNI; she's has no qualifications or history in the field, she
 has close ties to a number of enemies of the United States, she's blamed Russia's
 current fascism and wars on the west. She was confirmed on 2025-02-12
- 2024-11-14 RFJ Jr proposed as director of Health and Human Services he's pushed so much pseudoscience, from vaccines causing cancer to flouridation being harmful, that it's hard to find someone worse to get medical advice from; his appointment will put medicine far back. Covered well here:

- 2024-11-18 Brendan Carr (one of the authors of the Project 2025 extremist policy cookbook) to lead the FCC; among other things his writings suggest media companies may lose their licenses if they express views deemed anti-American
- 2024-11-19 Mehmet Oz as administrator for Centers of Medicare and Medical Services;
 Oz is a pseudoscientist TV personality who has pushed faith healing and a lot of
 ineffective alternative medicine treatments on his show, and he was one of the nutters
 pushing Hydroxy, an antimalarial drug, for Covid (which it is both ineffective at treating
 and which became scarce due to wide misuse after the craze for it emerged in alt-right
 circles).
- 2024-11-20 Matt Whitaker as NATO ambassador He has no relevant qualifications; presumably he was picked for the role because he was Trump's legal proxy when in Trump's first term his inappropriate ties to Russia came to light
- 2024-11-20 Kristi Noem for secretary of DHS South Dakota governor, with no background in anything DHS does.
- 2024-11-21 Linda McMahon for DOE wealthy donor who ran a fringe advocacy group, with very little background in education. By the low bar for Trump incoming appointees she isn't terrible, but this would be a bizarrely weak pick in a sensible administration
- 2024-11-22 Russ Vought, who wrote a lot of the most unconstitutional and nutty bits in Project 2025, is to lead the White House budget office
- 2024-11-22 Seb Gorka, far-right American TV host with ties to Hungarian Terrorism is apparently (not yet announced - needs verification) been proposed as national director for counterterrorism
- 2024-11-22 Martin Markary, who took a journey during the Covid19 area from responsible doctor to someone with fringe views who tried to push people to skip boosters, to head the FDA
- 2024-11-23 Janette Nesheiwat, a Fox News contributor who is director at CityMD (a NYC-local urgent care center) sounds slightly qualified by that latter point, but she has also has some dumb wobbly stances about vaccines, urging many youth not to get vaccinated because of inaccurate doubts about risks
- 2024-11-26 Jay Bhattacharya for director of the NIH. He's advocated for a number of the dumbest possible responses to Covid, as part of the group of cranks pushing the Great Barrington Declaration (he was one of its authors).
- 2024-11-27 John Phelan for secretary of the Navy. He's a campaign donor and investment banker with no military ties whatsoever.

- 2024-11-30 Charles Kushner for ambassador to France. Chilling and disgusting witness intimidation on his record for his felony (which Trump pardoned him for). Otherwise just a real estate developer no qualifications (not unusual for a diplomat), but why pick someone with such visibly poor morality?
- 2024-11-30 Kash Patel for FBI director Former assistant to Devin Nunes, but somehow worse, fabricated the "Nunes Memo" alleging FBI misconduct (later disclaimed by Nunes), pressured Trump to fire Mark Esper over refusing to use the military to squash protests, offered vague and broad promises to go after political opponents using the legal system (comments made on a Bannon podcast)
- 2024-12-12 Kari Lake for VOA director propogandist devoted to Trump's lies about the last election, no qualifications and missing the ethics and credibility required of the role
- 2024-12-14 Devin Nunes, the weird lawsuit guy who has incredibly thin skin (I've even donated to some of the legal defense funds of fellow conservatives he's gone after for criticism), as chairman of the Intelligence Advisory Board. This is also uncomfortable because Nunes has been acting as CEO of Trump's Truth Social thing.
- 2024-12-15 Dave Weldon, an antivax nut, to lead the CDC (the Legislature thankfully rejected his nomination
- 2024-12-08 Attempts to get his daughter in law Lara Trump, with no political experience, appointed senator in Florida to replace someone who will leave their elected post to take an appointed one in Trump's admin
- 2025-01-23 Brent Bozell to run US Agency for Global Media; Bozell is the founder of a far-right media group, and his appointment this way disrupts longstanding rules for a bipartisan oversight board to do the appointment
- 2025-02-04 Joe Kent, who has ties to American militia Movements, to be Director of the National Counterterrorism Center
- 2025-02-05 Neil Jacobs, who covered up Trump's miscommunications relating to a hurricane in 2019, to head NOAA (this is not a claim that Jacobs is incompetent, but rather that he should have stood up for Truth rather than Trump even on such a petty matter, and that he was appointed for dumb reasons)
- 2025-02-10 Not long after stating an intent to rehire someone who expressed a desire to make racism cool again and normalize indian hate, Musk had a 19-year old troll named Edward Coristine, who goes by the name "Big Balls", appointed as a senior advisor to the State Department
- 2025-02-13 Linda McMahon, professional wrestling mogul, with very little experience in education (1 year on CT's Board of Ed), is going through confirmation hearings to lead the Department of Education, a department that Trump's movement is interested in abolishing
- 2025-02-23 Dan Bongino, a far-right shock-jock conspiracy theorist, to act as deputy director of the FBI
- 2025-02-25 Joe Kent, a far-right conspiracy theorist with a history of repeating Kremlin talking points, nominated to become next director of the National Counterterrorism Center

- 2025-03-11 Russel Vogt, a political and religious extremist who authored much of the Project 2025 plan to destroy the US Government and who stated that he wants government employees to be in trauma, earlier reappointed to the OMB role he had in Trump's first admin, now also appointed to USADF and IAF boards
- 2025-03-15 Stephen Feinberg as deputy Defense Secretary; Feinberg has no background in any relevant topic, and is unaware that Russia invaded Ukraine (twice)
- 2025-03-27 Not a direct appointment (he was given this role by RFK), David Geier (who made a career of antivax advocacy tied to autism claims, working with his father who has done the same but was once a doctor - David is not) has been tasked with leading a federal study on vaccines and autism.
- 2025-03-28 Phil Hegseth (Pete Hegseth's brother), a professional blogger, serving as a senior advisor to DHS secretary. Nepotism isn't new in government, but it's a problem when it turns up
- 2025-03-29 Sarah Carter, a FoxNews journalist, as Director of the Office of National Drug Control Policy.
- 2025-04-16 Ed Martin Jr, president of anti-feminist group the Phyllis Schlafly Eagles and frequent contributor to Russian state media outlet RT, for US Attourney for DC.
- 2025-05-06 Vinay Prasad, candidate for FDA's CBER head (vaccine regulation);
 Prasad has fringe views on vaccines and apidemiology
- 2025-05-07 Casey Means, a candidate for Surgeon General, opposes vaccine mandates, consults with quacks on vaccine policy, opposes pasteurisation requirements for food, part of a movement of fake doctors that promote alternatives to germ theory.
- 2025-05-05 Thomas Fugate, a recent UT graduate with only a set of internships under his belt, heading DHS efforts to combat domestic terrorism
- 2025-07-10 Nick Adams,a far-right activist, as ambassador to Malaysia
- 2025-07-25 Paul Ingrassia, who suggested that white men are the most capable of appreciating Western culture and who suggested descendants of slaves pay reparations to descendants of slave owners, and who called for martial law and secession at the end of Trump's earlier term, picked by Trump to head Office of Special Counsel
- 2025-07-31 Joe Kent, a far-right conspiracy theorist, to lead the National Counterterrorism Center
- 2025-08-25 CDC picks Retsef Levi, an antivaxer, to lead the recently-fully-replaced immunisation practices committee
- Heather Honey, an anti-voting conspiracy theorist who created an anti-voting group known as Pennsylvania Fair Elections, appointed to a new role in DHS focused on election integrity
- 2025-09-25 Jeremy Carl, who suggested Trump's insurrectionists had it worse than Black Americans under Jim Crow laws, and who said white people celebrating Juneteenth, a holiday to commemorate the end of slavery in the United States, have "already surrendered", nominated for a prominent Department of State role managing coordination with international bodies like the UN, called for the execution of Randi Weingarten, and suggested there's no peaceful coexistence with people like Cori Bush.

Ukraine

- 2024-11-10 Donald Trump Junior mocks Zelensky's efforts to defend his country
 against the Russian invasion on Instagram, with a picture of Zelensky looking tired and a
 caption of "when your allowance is about to run out", suggesting that the Trump admin
 may cut off support to Ukraine and permit Russia to keep land it gained through both
 invasions. This is appeasement, it didn't work in WW2, and pushing for it now is
 irresponsible.
- 2025-02-20 Delegate to G7 objects to criticism of Russian aggression of Ukraine
- 2025-02-23 Demands Ukraine set up a \$500B fund to pay the US in order to continue helping it against Russia's invasion
- 2025-02-24 Sides with Russia to vote against a UN resolution condemning Russia for its invasion of Ukraine
- 2025-02-28 Invites Zelenskyy to White House, takes strikingly pro-Russian positions throughout the meaning ending in condemning the leader
- 2025-03-04 Ends CIA intelligence-sharing with Ukraine, making them more vulnerable to Russia
- 2025-03-06 Plan to end refugee status for over 200k Ukrainians in US who've fled Russia's invasion
- 2025-03-17 Withdraws from a multinational investigating Russia's war crimes in Ukraine
- 2025-04-24 Not long after another Russian attack on Ukraine's civilians, JD Vance boosts a post denouncing Zelensky for refusing to cede land to Russia, painting Ukraine's failure to surrender as an impediment to peace
- 2025-07-01 Lifts sanctions on Russian banks with close ties to Putin
- 2025-07-01 Ends various military supplies to Ukraine

Israel/Gaza

- 2025-01-22 Lifts sanctions on fascist settler groups within Israel, leading to an immediate uptick in violence against Palestinians in the West Bank

- 2025-02-24 Repeatedly calls the PM of Canada a governor as a way of pretending Canada is a US state.
- 2025-02-25 Navarro is pushing to remove Canada from an intelligence-sharing agreement as a way to pressure the country to accept annexation
- 2025-02-27 Navarro pushes for new negotiations on the borders between Canada and the US
- 2025-03-01 Pete Hegseth threatens Mexico with military action if it doesn't feel Mexico is sufficiently going after drug cartels
- 2025-03-09 Musk tells Poland's Foreign Minister, who was confronting him over his threats to turn off Starlink to force Ukraine to submit to Russian aggression, "Be quiet, small man".
- 2025-03-12 Trump claims the EU was set up to take advantage of the US (in a social media post the next day, he uses the term "screwing" while repeating the same claim)
- 2025-03-21 Blocks Canadian access to the Haskell Free Library and Operahouse, long a symbol of peace and cooperation between Canada and the US; as part of the closure, Secretary of Homeland Security Noem made a visit to the building, stepped into Canada, and claimed that Canada will be the 51st State (could've put this in the category below)
- 2025-05-02 Pressures Mexico to allow the US military to engage in the country
- 2025-05-06 Lutnick calls Canada a socialist regime that has been basically feeding off America
- 2025-09-04 Declaring foreign drug gangs as terrorist groups, Rubio brags about blowing up ships in Latin America with no cooperation or permission from governments there; under exceptional circumstances I think this could be justified, but Trump's use of this as a regular tactic is unacceptable and future such actions should be met by Latin American military responses
- 2025-09-15 Extrajudicial attack in international waters against a vessel the Trump admin claims were narcoterrorists from Venezuela

 2025-09-20 - Another extrajudicial attack in international waters. I will not cover more of these in the future (as there are likely to be many), but using the military to murder specific people in the open seas is a misuse of the military, terrible dliplomatically, violating norms and possibly laws, and makes the world less predictable and safe.

- 2025-03-13 Says that Canada only works as a (US) state
- 2025-03-14 Secretary of Commerce Lutnick talks on Fox News about wanting to absorb Panama and Greenland, digs into centuries-old story of founding of Greenland as part of building a justification for calling the country illegitimate
- 2025-03-18 -Trump FoxNews interview with Laura Ingraham: "Canada is meant to be our 51st state" and "One of the nastiest countries to deal with is Canada"
- 2025-03-23 Vance states that Denmark is not being a good ally and that the US will show more territorial interests in Greenland
- 2025-03-28 Vance tells Greenlanders they'd be better off as part of the US, claims Greenland isn't spending enough on security, and that the US should acquire Greenland for World Peace; Trump repeats that "we can't do without Greenland"
- 2025-04-03 In an interview, says he doesn't expect to use the military to attempt to gain control of Canada, but suggests it's possible he'll do so for other desired conquests
- 2025-04-06 Continues to press Canada to join the US in his first public meeting with Carney after Carney says Canada is not for sale
- 2025-05-27 Pressures Canada again by touting a Golden Dome missile defense system which he says would cost Canada \$61B to join unless it becomes the 51st US State
- 2025-08-27 Greenland discovers a number of US agents doing influence operations in Greenland designed to lay groundwork for a grab
- 2025-09-19 Trump demands control of Bagram Airbase, a soviet-built military base that the US controlled before it withdrew from Afghanistan (also erroniously claiming the US built it)

Power Grab beyond our norms

- 2024-11-10 EO draft to provide process to purge generals
- 2024-11-18 Social media posts by Trump stating an intent to declare a national
 emergency over illegal immigrants and use the military to help deport them (the problem
 here is that the military should not be used within our borders for purposes like this), and
 statements by Miller that they may also declare a public health emergency to avoid legal

- 2025-01-09 Mike Waltz, Trump's future National Security Advisor, announced a
 directive to remove national security civil servants loaned from other departments,
 explicitly referencing Alexander Vindman's exposure of Trump's illegal acts in his first
 term as something he'd like to avoid
- 2025-01-21 Executive orders aimed at ending birthright citizenship; this is an abuse of process as Birthright Citizenship is part of our Constitution (through Amendment), and is not something an EO can end.
- 2025-02-11 Gives the non-congress-approved "DOGE" pseudo-department authority into all hiring for civil service positions
- 2025-02-18 Signed EO that asserts that only the presidency or AG can speak for the US when interpreting laws carried out by the executive branch, attempting to cut judicial review out of how our government works. This also claims to end independence of independent agencies, with limited exceptions for the Fed.
- 2025-02-20 Removes a number of top military officials and lawyers, reportedly to seek
 people willing to offer him personal loyalty rather than loyalty to the nation; Hegseth later
 says in an interview about the lawyers that he wants to remove people who may act as
 roadblocks to Trump's future actions
- 2025-02-21 In an effort to get compliance over sports policy, threatens US governors with pulling funding if they do not comply, telling them that he is the federal law
- 2025-03-04 Selling a variety of crucial government buildings, including the headquarters of the Department of Justice and the headquarters of the Department of Labor. The next time we have a reasonable government, repurchase and screening of these buildings will be amazingly expensive.
- 2025-03-18 Removed both Democratic FTC commissioners; the FTC is an independent agency and has had commissioners of both parties
- 2025-05-28 Linda McMahon, in an interview: "Universities should continue to be able to do research as long as they're abiding by the laws and in sync, I think, with the administration and what the administration is trying to accomplish."
- 2025-06-26 Pressuring University of Virginia to fire its president James Ryan as part of govt efforts to control or extinguish it
- 2025-06-26 Pressures congress to investigate the J6 committee that investigated his misdeeds
- 2025-07-31 Forces Smithsonian to remove him from an exhibit on impeachment
- 2025-08-07 Pressures Intel's CEO to resign over a perceived closeness to China, also issues an EO to try to pressure banks to be friendlier to funding conservative activism

- 2025-09-06 Trump posts on Truth Social that Chicago, having resisted Trump's efforts
 to deploy the Texas's national guard to the state, is "about to find out why it's called the
 Department of WAR" (Trump's name for the Department of Defense); the post has a
 disturbing "Chipocalypse Now" image
- 2025-09-12 Stephen Miller says the left is inspiring terrorism, vows to dismantle the left, and that spreading hate will lead to law enforcement finding people, take their money

- and power, and *if* the law is broken, taking their freedom (the phrasing indicating that people who don't break the law may still face repression from law enforcement
- 2025-09-27 The US, in a second likely breach of international law relating to the UN, revoked the visa of Colombia's President Petro, having him join Abbas in leaders unable to address the UN in its NYC headquarters.

- 2025-10-01 Entering this year's government shutdown, employees of various agencies
 are given phrases they're instructed to use in autoreplies to emails, that violate the Hatch
 Act by using official government communications towards explicitly political ends (not
 even cause-based, but flattering Trump and blaming Democrats); government websites
 likewise violate the hatch act with banners:

- 2025-10-02 Resumes practice of extorting universities over a variety of policy changes
- he wants them to make, to avoid funding cutoffs
 2025-10-03 Calls the Democratic Party (in a social media post) "The Party of Hate,
- Evil, and Satan"
- 2025-10-03 Claims that he changed official policy condoning violence against those that spit at police
- 2025-10-03 Announces a commemorative coin with Trump on the face, violating longstanding norms and laws against US currency featuring living individuals

Press

- 2024-11-24 Musk jokes or hints about buying MSNBC to end hostile press coverage (which also uses a tacky juxtaposition of religious imagery and a prostitute)
- 2025-01-23 Trump's FCC chair Brendan Carr looking to punish news stations that don't give Trump favourable coverage, likely violating 1A protections
- 2025-02-11 AP barred from attending events because they would not call the Gulf of Mexico by Trump's new name for it, an attack on freedom of the press (and quite petty)
- 2025-02-24 DC Attorney Edward Martin states that "As President Trump's Lawyers, we are proud to fight to protect his leadership as our President and we are vigilant in standing against entities like the Associated Press that refuse to put America first"
- 2025-02-26 White House announces that it will determine which and how news outlets will cover Trump in the future. This replaces the older system where proper news orgs follow the POTUS everywhere and gives the Trump admin more control over the press
- 2025-03-14 In a speech at the DOJ, claims that CNN and MSNBC are illegal
- 2025-04-18 Responding to a court order restoring AP's access to the press pool for briefings, Trump entirely removed the wire press pool in order to exclude AP

- 2025-06-25 Calls for Natasha Bertrand (CNN) to be fired over her reporting on his lies on various topics (his post is on Truth Social)
- 2025-06-27 Threatens to sue New York Times for reporting on an (acknowledged to be real) intelligence report on his military strike on Iran
- 2025-07-01 Threatens to sue CNN over reporting on an app that crowdsources warnings that ICE agents are in an area
- 2025-07-01 Pushes Paramount into a settlement over an interview they did with former Presidential candidate Harris, claiming routine edits amounted to election interference (this is covered by the First Amendment), where they agreed to donate millions to his future Presidential Library
- 2025-07-25 Brendan Carr, Trump's FCC chair, says he'll put a bias monitor in place covering SkyDance and CBS as part of their merger deal, in a move that will likely ensure friendly coverage of Trump's admin and movement
- 2025-07-27 Sues Rupert Murdoch and Fox News for running a story on Trump's involvement with Epstein
- 2025-08-18 Trump attacks journalist Nicolle Wallace, suggesting he'll pressure NBC to fire her over critical coverage
- 2025-08-24 Because "ABC and NBC fake news" don't praise him enough, suggests they're actually a branch of the Democratic Party and should have their broadcast licenses revoked by the FCC, in a Truth Social post
- 2025-09-16 \$15B defamation suit against NYTimes, devoid of legitimate legal claims, over critical coverage and endorsement of Harris
- 2025-09-18 Again suggests that because network coverage of him is mostly negative,
 "maybe their license should be taken away. It will be up to Brendan Carr."

Race related matters

(For these, they're written from the perspective of being skeptical of DEI and progressive approaches to race, but supportive of tolerance and accurate history)

- 2025-03-15 Dramatically overbroad removal of minorities from mention on government public pages, with mention of honors often tagged with "DEI" in public URLs and occasionally in page content; it is plausible that some mentions were only done for representativeness and should be removed, but the blanket removal went so far beyond that and seems so careless as to be indefensible, as if someone made a list of things to look into expecting a 5% removal rate and someone else just did a "select all" and "apply". A prime example being removal of articles on the Navajo code talkers.
- 2025-03-18 Removes longstanding explicit ban on allowing federal contractors that have segregated facilities (already illegal under general workplace laws)

Weird culty stuff

(for this we're looking more broadly, on the theory that anyone decent seeing a cult of personality forming around themselves would shut it down)

- 2025-02-14 Claudia Tenney introduced a bill to make Trump's birthday a national holiday
- 2025-02-26 Joe Wilson drafting legislation to put Trump on a \$250 bill

•
