For Savor the River Valley's Farm & Food Tour, April 25th, 2026, Savanna Institute is holding sweepstakes to give away a one-night stay at Elderflower Retreat! You can enter for a chance to win an overnight for up to four people.

1. **Eligibility:** Elderflower Retreat Overnight give-away are sweepstakes open to all persons aged 21 or older. Participants must have a valid state issued ID and email address. Employees of the Sponsor and its affiliates, including Savor the River Valley, and advertising agencies, and their immediate families (spouse and parents, children and siblings, and their respective spouses) and individuals living in the same households of such employees, are ineligible. Any eligible individual participating in the Overnight Give-a-ways will be identified as a "Participant" in these rules.

2. **Sweepstakes Periods and Drawing Dates:**

All times are Central Daylight Time. Sponsor's computer is the official time-keeping device for the Give-a-way.

3. **To Enter:** No purchase is necessary to enter. To enter, Participants may complete the entry form in-person at the Elderflower location only (participant will be allowed one (1) entry). Each person who submits an entry agrees to be bound by these Official Rules and accepts the decisions of Sponsor, which are final and binding. All entries become property of the Sponsor and will not be acknowledged or returned. Incomplete entries are not eligible. Entries must be received by 3:59 p.m. CDT on the applicable Sweepstakes Close date. No photocopied, mechanically, or electronically reproduced entries accepted. Any attempt by any person found to enter or in any way attempt to obtain more than the authorized number of entries will be found to be ineligible, and the entries will be disqualified. Participation must be by the Participant. Participants are required to provide truthful information, and Sponsor will reject any entry that it discovers to be false or fraudulent. Sponsor will disqualify any entry from individuals who do not meet the eligibility requirements.
4. **Drawing:** Sponsor will hold a random drawing for the Give-a-way on the drawing dates identified above. There will be one (1) potential winner, and winner will be notified within 5 business days after the random drawings take place via the email address provided. Odds of winning depend on the total number of eligible entries received. Participants need not be present to win. All potential winners are subject to eligibility verification by Sponsor, whose decisions are final and binding. **A Participant is not a winner of any prize, even if notified of being a winner, unless and until the Participant's eligibility has been verified.**
5. **Prizes:** Winner of the Give-a-way is responsible for any costs in excess of the applicable voucher amount. Any transportation to and from the airport, meals, upgrades, excursions, taxes, gratuities, and other charges are the sole responsibility of the winner. Winners are responsible for booking all travel. Travel must be booked and completed by the voucher expiration date. No substitutions, cash equivalents, or transfers of prize permitted. Dates of travel are based on availability at time of booking, and travel restrictions may apply. Expiration dates will not be extended, and travel must be completed on or before the voucher expiration date.

6. **To Claim Prize:** Winners will be notified via email and will be required to complete and sign an Affidavit of Eligibility, Liability Release, Publicity Release, and IRS Form W-9 (collectively, the "Required Documentation"). Winner must claim the prize and return the signed Required Documentation within 30 days of notification. The potential winner will be disqualified and an alternate winner will be selected by random drawing from among the remaining eligible entries in the following circumstances: the potential winner cannot be contacted using the information provided or fails to respond to Sponsor's attempt to notify them of selection within fourteen (14) days; any notification is returned as undeliverable or yields an error of undeliverable type or "bounce back" email (regardless of whether the message is ultimately delivered to the recipient); Sponsor is unable to verify potential winner's eligibility; potential winner fails to sign and return the Required Documentation within the required time period or fails to comply with these Official Rules; a potential winner is unable or unwilling to accept the prize as stated; or the potential winner cannot be verified as eligible for any other reason. including associated with entering the Give-a-way, but in no event attorneys' fees. Sponsor reserves the right to correct clerical or typographical errors in the Give-a-way materials or these Official Rules. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. **THE EXCLUSIVE JURISDICTION FOR ANY DISPUTE SHALL BE IN THE FEDERAL OR STATE COURTS LOCATED IN IOWA COUNTY, WISCONSIN.**
