- Soft rollout of certification is complete and moving to all districts

Funding waves are moving forward. FCDL letter format has changed, better formatted. These come via email to the person who did the paperwork, so keep an eye out for these, and pay particular attention if the person who did the paperwork doesn't work over the summer. 486 must be certified no later than 120 after the service start day or 120 after the FCDL. Suggestion is to file it as soon as you can right after getting your FCDL (after July 1 though). Make sure you have your banking info on file (form 498) so they can get money to you electronically. BEAR forms are still not in EPC system.
