Kiwaatule-2030: Building Post-Colonial Urban Futures



I. Overview

Kiwaatule-2030 is a community-led uprising against urban fragmentation and dysfunction. We are creating the conditions for pooling land development decisions in the Nalubaaga Bioregion to reverse the extinction of our wetland ecosystem and catalyze a regenerative urban future.

Nalubaaga wetland bioregion in Kampala?



We are executing strategic activities across three spheres of influence: Land, Governance, and Money – each an evolutionary shift toward enriching our species' relation with life.

LAND: Transitioning fragmented parcels of private land into a co-stewarded ecosystem. **GOVERNANCE:** From top-down control to Obutaka – the land-sourced ancestry to belonging, authority and duty to care for all life in our place, all through a Distributed Stewarding Cooperative.

MONEY: Redirecting money from extraction to enriching life – relations in our place.

In 5-10 years, this triple-shift should dream and grow us into a future of **ecological restoration**, reforesting, and rewilding Nalubaaga wetland into a nature park; **social flourishing** (renewing a culture of stewarding life, rebuilding essential services and spaces), and **economic viability** (innovating informal supply chains into a new economy

of co-owned enterprises, services, real estate, hospitality, eco-spiritual tourism, finance, etc).

In this learning-by-doing initiative, we're building the cultural commons (processes, structures, systems) to gracefully transition urban land from speculative markets into living commons, all rooted in Obuntu.

3 Spheres of Influence

3 systemic shifts

Money shift: -

Modern way: Money as tool for extraction, chases crises and symptoms, reinforcing dependency and depletion \rightarrow

Obuntu way: Money as kin, follows the healing of human-nature relations, reinforcing coherence, wholeness and resilience in place.

Governance shift:

Modern way: Govern urban places as machines – top-down, control, extract \rightarrow

Obuntu way: Co-steward urban places as living commons – listen, care, co-evolve.

Land Shift:

Modern way: Landowning titles entitle 'USING' land as a resource \rightarrow

Obuntu way: Landstewarding interests in 'CARING' for land as a source of all life. Land begets life, not debt.

II. Land Shift:

Modern way: Land as a resource → Obuntu way: Land as a source of life

Purpose: To shift public consciousness from *using urban land as a commodity for extractive accumulation* to *caring for land as a source of all life*. The means transitioning from fragmented plot development to coordinated life-enriching land development and bioregional stewarding.

Product: A collective land stewarding layer on top of private landholdings that enables landowners to pool land development decisions, attracting long-term finance for:

- Restoring, reforesting and rewilding Nalubaaga wetland as a living system contributing to Kiwaatule's vitality, viability, and co-evolution to higher-orders of potential.
- Rebuilding 5,000+ regenerative housing units, enterprises and services.
- Reviving land-based cultures, caring for biodiversity and climate resilience.

Process:

- 1. **Rebuild trust** through Neighbourhood Kinship Dialogues and one-on-one dialogues surfacing what people value, challenges and the life they dream of in Kiwaatule.
- Rebuild capacity for collective decision-making through the Obuntu Resets System, where landowners jointly decide on priorities, roadmaps, and budgets for Quick, Inexpensive, Simple, Systemic acts of collaboration with the community.
- 3. **Create a galvanising story of Kiwaatule's renewal** coalescing stakeholder interests through a Landcare Visioning Center where landowners ko-design with specialists regenerative scenarios for 2030.
- 4. **Secure landowners' interests** by engaging authorities to convert land-owning titles into land-stewarding interests that recognize collective governance and pooling of land development decisions.
- 5. **Organise Land Recommoning ceremonies,** welcoming land back from speculative markets to living commons while celebrating recommoners and motivating others.
- 6. **Underwrite the transition** through a Land Recommoning Fund coordinating blended finance for temporary relocation, ecosystem restoration, and rebuilding.
- 7. **Restore, reforest, rewild** Nalubaaga into a thriving biodiverse nature park, unlocking her eco-spiritual tourism potential through common-based enterprises.

Relational Capability:

- Landowners evolve into **landstewards** guardians of soils, waterways, air, biodiversity, and the cultural spirit of loving and caring for their place.
- They sustain natural, social, and economic vitality, enhancing Kiwaatule's capacity to continually evolve into higher orders of potential.
- Land begets life, not debt.

III. Governance Shift:

Modern way: Govern urban places as machines – top-down, control, extract → **Obuntu way:** Co-steward urban places as living commons – listen/sense, care, co-evolve.

Purpose: Building Capacity & Capability for Collective Decision making as a stepping stone to a bioregional stewarding/governance model rooted in Obuntu, where Emitala (natural boundaries) shape our social consciousness rather than arbitrary political lines.

Product:

A Distributed Stewarding Cooperative with processes, structures, and systems enabling landstewards, the wetland herself, and future generations to participate in right relation with their place. All through collective decision-making grounded in **Obuntu—the nested interdependence of all life** in a place/bioregion:

- Digital platform with quadratic voting: "1 decimal of land = 1 stewarding vote & 1 share"
- Wetland as structural counter-balancer against big landowners participating in relational decisions.
- Obuwanika (Stewarding) Fund for collective resource allocation.
- **Living policy lab** to experiment (with the state) Obuntu-sourced policies for the future of bioregional planning and development.

Process: a four-stage gathering cycle redirecting our *attention* and *intention* toward Obuntu.

- 1. **Knowledge gathering:** Identify a broken relation, gather Indigenous Knowledge and weave it with modern insights as sources a new **pool of shared understanding** to inform the ko-design of how that relation can be enriched.
- Kin gathering: Landstewards (who can), the wetland proxies, and future generations
 make sense of gathered knowledge creating a new pool of shared meaning and
 pathways.
- 3. **Decision gathering:** Landstewards, the wetland, and future generations through quadratic voting (1 decimal of land = 1 vote) via a digital platform practice collective decision-making on priorities, roadmaps or budgets; creating and endorsing a new **pool** of shared intent for our place.
- 4. **Action gathering:** Agreed **shared actions** are assigned and implemented to create evolutionary change into a thriving future. Where necessary, impact is measured, reported, and the cycle begins again to restore and enrich the next broken relation.

Relational Capability:

- Communities develop the ability to self-organize around natural boundaries (Emitala), self-manage shared resources, and self-regenerate through trust, collaboration, and cultural renewal.
- 2. Spiritual renewal: individuals see themselves contributing to something larger than self.

- 3. They gain capacity to coordinate internal and external resources long-term regenerative finance, policy support, and knowledge partnerships for ongoing evolution.
- 4. They also **restore the human role of stewarding life on Earth** shifting from landowning to landstewarding, and from fragmented, plot-by-plot development to **coherent bioregional stewardship** guided by the integrity of place.
- For urban development, this builds the cultural and process infrastructure needed to gracefully transition land from speculative markets to living commons — transforming diminishing returns on land into regenerative value that enhances natural, social, and economic health.

IV. Money Shift:

Modern way: Money as tool for extraction, chases crises and symptoms, reinforcing dependency and depletion \rightarrow

Obuntu way: Money as kin, follows the healing of human–nature relations, reinforcing bioregional coherence, wholeness and resilience.

Purpose: Automating catalytic funding for regeneration, and placing relational health — not top-down impact metrics — at the center of funding decisions, through community-led sense-making, fundraising, implementation, measurement, reporting, and verification.

Product: Obuntu Resets – a governance process + platform converting broken human-nature relations into credible, measurable, fundable community issued units to fund relation-enriching community activities like:

- Nature-aligned waste to value activities (e.g. \$10/reset)
- Wetland restoration activities, like replanting native species, et.c.
- Enabling clean cooking energy transitions (eco-stoves pay-as-you-go e.g. \$6/reset)
- Support healthy/indigenous food systems through flexible farmer contracts
- Strengthen stewardship capacity and cultural renewal
- Support mutual credit networks and community-owned enterprises, etc.

Process:

- 1. <u>Build: Obuntu Resets</u> as 2-in-1 relational (bioregional governance + fundraising) digital platform for resetting money flows towards enriching relations in place.
- 2. **Assess** broken relations: Community committee identifies broken human-ecological relations (waste→wetland, residents→clean energy, youth→purpose)
- 3. **Issue** Obuntu Resets: Convert assessments into units enabling institutions / individuals with environmental / social interests and obligations to invest in relation-healing actions.
- 4. **Govern:** The *Obuwanika (Stewarding) Fund* enables landstewards, wetland and future generations to collectively decide how funds are used for regenerative activities, using quadratic voting to direct funds toward Quick, Inexpensive, Simple and Systemic activities that heal broken relations.

- 5. **Activate:** actions are implemented generating ripple effects, each Reset creates cascading relational healing (e.g., waste Resets improves human—wetland—soil—food—hope—collective agency—stewardship)
- 6. **Grow:** funder network, build a community of individual and institutional funders who as co-stewards invest in long-term bioregional relational health (not offsets).

Relational Capability:

- 1. Communities gain the capacity to identify, ko-design, and fund life-centered initiatives.
- 2. Investors and donors evolve into co-stewards of relational health, where;
- 3. Money flows according to life's needs enriching relations rather than depleting them through imposed projects or metrics.
- 4. Each restored and enriched relation strengthens the web of life, reinforcing coherence, wholeness and (natural, social, economic) resilience.

Total Investment to Date: \$30,000

Key Outcomes:

- General awakening to the potential of a new future across 16 of 28 neighbourhoods, on over 500 acres of land.
- 13 core relations are moving from broken/absent → emerging; residents ≒ trust, residents ≒ care, residents ≒ collective will, residents ≒ hope, residents ≒ wetland, residents ≒ waste, residents ≒ unity, landowners ≒ stewardship, landowners ≒ collective decision-making, residents ≒ Obuntu, etc.
- 24 out of 27 landowners (representing ~90% of 250+ landowners across 28 neighbourhoods) are excited to collectively govern 500+ acres and co-steward their place to higher potential. 60+ attended the Conference of landstewards and 38 enrolled to register NVC.
- Landowners nominated a 19-member Organizing Committee that is now operational and meeting regularly, drafted a charter/bylaws for the cooperative.
- Legal registration process for NVC underway with innovative wetland shareholding, and land-based shares model
- Policy dialogue initiated with city and national authorities to support a community-led, state-enabled model.
- Evidence base established showing genuine community-led demand (not imposed project)
- Shift from "my plot" language → "our place" language emerging in community

Expected Relational Health Outcomes:

- Obuntu Governance system transitions from prototype → operational (Obuntu Gathering Cycle + Obuwanika Fund + Charter / Bylaws + NVC registration complete)
- 10 + key relations progress from fragile → healing
- 300 + households start adopting regenerative practices
- 10+ local enterprises embedded in regenerative economy
- Obuntu Resets digital platform live enabling continuous collective governance and funding
- Formalise institutional collaboration established with KCCA, NEMA, and universities for policy learning
