- 2. Kyle presented brief history, as included on http://i.mp/26-green
- 3. Topics of discussion
 - Concern with inability to find close (within one block) parking, especially for neighbors at south end of 2500 block

Proposed solutions:

- i. Add additional parking on east end of 26th Street Green space
- ii. Request removal of meters on 25th Street
 - 1. This block of 25th Street is currently zoned commercial, but is mostly residential
 - Linda had reached out to Councilman Stokes on this, but was awaiting a response
- b. Concern with safety ("health and wellness" language proposed) threats that might arise with the creation of the 26th Street Green

Proposed solutions:

- i. Keep the space well maintained to promote respect for the space
- ii. Include positive activities and programming
- iii. Investigate bright pedestrian lighting on 300 block of 26th Street
- iv. Engage with local services to reinforce support services for those in need
- c. Community engagement and communications
 - Need to be more intentional about including underrepresented groups and communicating beyond electronic sources

Proposed solutions:

- 1. Meet at communal space, rather than individual homes
- Have block ambassadors responsible for doing door-to-door and personalized outreach
- ii. Need to keep all neighbors (even those who don't attend meetings) up-to-date about park progress and activities through multiple communications channels

Proposed solutions:

- Continue to use Facebook and Nextdoor and promote widely the use of the newly developed website http://j.mp/26-green
- Send out periodic email updates to neighbors who have provided their email and requested updates
- Build sign (perhaps a sandwich board) to keep in 26th Street Green with updates and postings; this is something the Abell Community Association has had luck with
- d. Friends Group purposes
 - Desire to broaden the scope of this Friends Group to include the entire 26th St. corridor (perhaps name "The Friends of the 26th Street Corridor")
- e. Intended and unintended benefits of the park to date

- i. Kids utilize the space for biking, sports, recreation
- ii. Reduction in cars speeding down Huntington Alley
- iii. Reduction in sex solicitation activity on 300 block of 26th St.
- 4. Friends group goals and purpose were discussed to potentially include:
 - a. Coordinate with DoT & other community groups
 - i. Attend CVCA Land Use Committee Meetings
 - b. Determine and promote rules and guidance for space
 - c. Contribute to space design
 - i. With focus on parking concerns and safety/wellness

 - g. Apply for and manage funding
