

Terms of Use

1. Agreement

These Terms of Use ("Terms") are a legal agreement between you and me, the individual developer of this mobile application (the "App"). By downloading, installing or using the App, you agree to be bound by these Terms and the Privacy Policy.

If you do not agree, do not install or use the App.

2. Eligibility

You must be at least 13 years old (or older, if required by local law) to use the App. To make purchases or subscriptions, you must be able to form a legally binding contract.

3. License

I grant you a limited, non-exclusive, non-transferable, revocable license to use the App on a device that you own or control, solely for your personal, non-commercial use, in accordance with these Terms and the rules of the App Store.

4. Prohibited Use

You agree not to:

- copy, modify, distribute or sell the App or any part of it;
- reverse engineer, decompile or attempt to extract the source code, except where this is permitted by law;
- remove or alter any notices or legal information included in the App;
- use the App for any unlawful purpose or in a way that could harm others;
- interfere with or disrupt the App, servers or networks.

5. In-App Purchases and Subscriptions

If the App offers paid features:

- purchases and subscriptions are processed via the Apple App Store using your Apple ID;
- prices and subscription details are shown in the App Store and/or in the App;
- subscriptions may renew automatically unless you cancel them at least 24 hours before the end of the current period;
- you can manage or cancel subscriptions in your Apple ID account settings;
- deleting the App does not cancel your subscriptions.

Refunds for purchases made via the App Store are handled by Apple according to their rules.

I do not guarantee that the App will be error-free, uninterrupted or free from harmful components.

9. Limitation of Liability

To the maximum extent permitted by law, I am not liable for:

- any indirect, incidental, special, consequential or punitive damages;

- any loss of data, profits, revenue or business opportunities;
- any damages resulting from your use of or inability to use the App.

If my liability cannot be fully excluded under applicable law, it will be limited to the amount you have paid for in-app purchases or subscriptions in the App during the twelve (12) months preceding the event giving rise to the claim.

You may stop using the App at any time and delete it from your device.

I may suspend or terminate your access to the App at any time if you violate these Terms or if I decide to stop providing or supporting the App. Upon termination, the license granted to you ends and you must stop using the App.

I may update these Terms from time to time. When I do, I will update the "Effective date" at the top and may show a notice in the App. Your continued use of the App after changes become effective means you accept the updated Terms.
