

## Terms & Conditions - Narayana Health NEET scholarship Test

- 1. Narayana Health Scholarship Test(s) ("**Test(s)**") are organized by Sorting Hat Technologies Private Limited ("**Unacademy**") in collaboration with Narayana Health to create social impact and uplift livelihood of the NEET aspirants and to break the geographical and affordability barriers that exist when it comes to accessing the best coaching for competitive exams. The Test(s) shall be conducted on <a href="www.unacademy.com">www.unacademy.com</a> ("**Unacademy Platform**").
- 2. The Test(s) are governed by these terms and conditions, the online Privacy Policies, Online Terms of Use and Community Guidelines and any other terms and conditions available on <a href="mailto:the-Unacademy Platform">the Unacademy Platform</a> as may be amended from time to time at the discretion of Unacademy ("Terms").
- 3. Students of NEET droppers/repeaters of Kolkata and Bangalore whose combined parental income are less than 6.5 Lakh and 12th/PUC marks more than 90% are eligible to take the Test(s).
- 4. Unacademy shall solely depend on the list of eligible students ("**Participants**") provided by Narayana Health and shall not be under any obligation to verify the same. By Participating in the Test(s), Participants are agreeing to the Terms stated herein.
- 5. The Participants must register and enroll themselves on the Unacademy Platform prior to taking the Test(s). Participants who have not registered and enrolled shall not have access to the Test(s). Test(s) shall be conducted on such dates as may be specified in the Test(s) page.
- 6. Test duration and Format: Test(s) shall be for a duration of 60 minutes or such other duration as specified on the Content(s) page. Responses to the Test(s) questions must be submitted by the Participant while the Test(s) and the questions are live. Test(s) are available only for one time participation by an individual irrespective of whether multiple/unique log-in credentials were used. Participants shall not be allowed to restart the Test(s) if they fail to log-in when the Test(s) begin. Participants are not allowed to log out and then subsequently log in to complete/redo the test through the same or different credentials. Unacademy shall not be responsible for any failure to log-in or complete the Test(s) due to any technical issues either at Unacademy's or Participants' end.

## 7. Participant Ranking:

a. Ranking shall be based on the number of marks scored and the interview conducted. Scholarship: Participants who hold top 130 ranks ("Rankers") will be awarded the Scholarship. "Scholarship" shall mean Unacademy Offline Classes in Kolkata and Bangalore Centre for a competitive exam for a period of 1 year. All Scholarships are subject to Participants adhering to the Terms.

Rankers will receive an Unacademy offline NEET UG subscription in Kolkata and Bangalore

8. **Disqualification:** Unacademy may disqualify any Participant(s), without assigning any reason or being liable in any manner, if in Unacademy's sole discretion, there is reason to believe that any unethical or fraudulent or unprofessional or unwarranted means were used



- by any Participant(s) to gain an advantage in the Test(s). Participant shall be disqualified if he/she has an active subscription of more than 6 months as on the date of the Test.
- 9. If at any point it is discovered that a Participant has engaged in unethical conduct including but not limited to having prior access to the questions in the Test(s), use of any circumventing technology/means to manipulate the product algorithm or external assistance or any act giving the Participant an unjust or unwarranted advantage over other Participants, Unacademy may at its sole discretion, without being liable in any manner, cancel any Scholarship and bar the Participant from using any product or services offered by Unacademy.
- 10. Any Participant found using or participating in the Test(s) through multiple accounts shall be immediately disqualified; shall not be eligible for Scholarship and shall be barred from participating in any future Test(s) at the sole discretion of Unacademy.
- 11. A Participant taking part in the Test(s) and declared to be a Ranker but is unable to fulfill any one or more eligibility requirements specified herein as on the date of closure of Test(s), shall be disqualified from receiving Scholarship under the Test(s). Any communication, clarification, query or dispute in this regard by the Ranker, or any of the legal heirs/guardians of the top ranker in any manner will not be entertained by Unacademy and Unacademy's decision shall be final and binding. Test(s) are run at the sole discretion of Unacademy
- 12. Participants who win the Scholarship shall not be eligible to participate in future Test(s) for a period of 12 months.
