

## Privacy Policy (Apps)

The App may also collect information about how your device has interacted with the App, including the pages accessed and links clicked. - To comply with legal obligations: We use your personal information as necessary to comply with applicable legal, tax or accounting requirements. We also use your personal information as necessary when cooperating with law enforcement agencies, courts, and/or government authorities in accordance with our legal obligations under applicable laws.
- Third party service providers and vendors who provide services, including data processing services, for the Organization, for example, Pushpay.
- Others who otherwise process personal information for purposes that are described in this Privacy Policy.

### **Data security**
