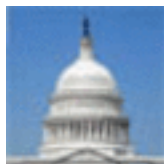

Administration grants another 200 ObamaCare waivers

The *Hill* reports:

The Obama administration **approved** 204 new waivers to Democrats' healthcare reform law over the past month, bringing the total to 1,372. The waivers are temporary and only apply to one provision of the law, which requires health plans to offer at least \$750,000 worth of annual medical benefits before leaving patients to fend for themselves. #1 REPEALING H.R. 4872

House Votes for Repeal of Health Law in Symbolic Act

WASHINGTON — The House voted Wednesday to repeal the Democrats' landmark health care overhaul, marking what the new Republican majority in the chamber hailed as the fulfillment of a campaign promise and the start of an all-out effort to dismantle [President Obama](#)'s signature domestic policy achievement.

The vote was [245 to 189](#), with 3 Democrats joining all 242 Republicans in support of the repeal.

Leaders of the Democratic-controlled Senate have said that they will not act on the repeal measure, effectively scuttling it.

While conceding that reality, House Republicans said they would press ahead with their “repeal and replace” strategy. But the next steps will be much more difficult, as they try to forge consensus on alternatives emphasizing “free market solutions” to control health

costs and expand coverage.

Even as four House committees begin drafting legislation, Republicans said they would seek other ways to stop the overhaul, by [choking](#) off money needed to carry it out and by pursuing legislation to undo specific provisions, like a requirement for most Americans to carry [health insurance](#) or face penalties. The law is also under challenge in the federal courts, with the individual coverage requirements fueling a constitutional battle likely to be decided by the [Supreme Court](#).

The House vote was the first stage of a Republican plan to use the party's momentum coming out of the midterm elections to keep the White House on the defensive, and will be followed by a push to scale back federal spending. In response, the administration struck a more aggressive posture than it had during the campaign to sell the health care law to the public. With many House Democrats from swing districts having lost their seats in November, the remaining Democrats held overwhelmingly together in opposition to the repeal.

On the House floor, the resulting debate was a striking reprise of the one that engulfed Capitol Hill from the spring of 2009 until March 2010, when Mr. Obama signed the health care law.

And while the tone was slightly subdued in the aftermath of the attempted assassination of Representative [Gabrielle Giffords](#) in Arizona, the debate showed that the divisions over the law remained as deep as ever.

The three Democrats who crossed the aisle to support the repeal were Representatives Dan Boren of Oklahoma, Mike McIntyre of

North Carolina, and Mike Ross of Arkansas, all of whom opposed the law last year.

Ms. Giffords, who had supported the law, remains hospitalized in Arizona and was the only House member who did not vote.

Republicans denounced the law as an intrusion by the government that would prompt employers to eliminate jobs, create an unsustainable entitlement program, saddle states and the federal government with unmanageable costs, and interfere with the doctor-patient relationship. Republicans also said the law would exacerbate the steep rise in the cost of medical services.

“Repeal means paving the way for better solutions that will lower the cost without destroying jobs or bankrupting our government,” the House speaker, [John A. Boehner](#) of Ohio, said. “Repeal means keeping a promise. This is what we said we would do.”

Democrats, eager for a second chance to sell the law, trumpeted the benefits that have already taken effect. These include protections for people who would otherwise be denied insurance coverage based on a pre-existing medical condition, the ability for children to stay on their parents’ policy until age 26, and new tax breaks for small businesses that provide health coverage to their workers.

Representative [John Lewis](#), Democrat of Georgia, said, “It is unbelievable that with so many people out of work and millions of people uninsured, the first act of this new Congress is to take health care away from people who just got coverage.”

The health care law, which Congress approved last year without a single Republican in favor, seeks to extend insurance to more than 30 million people by expanding [Medicaid](#) and providing federal

subsidies to help lower and middle-income Americans buy private coverage.

Republican leaders said they had not set any timetable for the four committees drafting alternatives to the law. “I don’t know that we need artificial deadlines for the committees to act,” Mr. Boehner said. “We expect them to act in an efficient way.”

Republicans said their package would probably include proposals to allow sales of health insurance across state lines; to help small businesses band together and buy insurance; to limit damages in [medical malpractice](#) suits; and to promote the use of health savings accounts, in combination with high-deductible insurance policies.

Republicans also want to help states expand insurance pools for people with serious illnesses. The new law includes such pools, as an interim step until broader insurance coverage provisions take effect in 2014, but enrollment has fallen short of expectations.

Representative Paul Broun, Republican of Georgia, said that allowing people to buy insurance across state lines would “expand choice and competition.” And he said businesses could negotiate better insurance rates if they could join together in “association health plans,” sponsored by trade and professional groups.

But state insurance officials have resisted such proposals, on the ground that they would weaken state authority to regulate insurance and to enforce consumer protections -- a concern shared by Congressional Democrats.

Some Republicans seemed sensitive to accusations that repeal would strip away new patient protections and leave millions of

Americans without insurance.

Representative Joe Heck, Republican of Nevada and a physician, said he supported some goals of the new law: “making sure people don’t lose their coverage once they get sick; letting dependent children stay on their parents’ insurance until they turn 26; making sure anyone who wants to buy insurance can purchase a policy, regardless of pre-existing conditions.”

Representative [Joe L. Barton](#), Republican of Texas, said, “There are some things in the new law that we think are worth keeping,” including a procedure for approval of generic versions of expensive biotechnology drugs.

But Mr. Barton and other Republicans returned to a core objection to the law, which they said extends the reach of government too far.

“We believe that you shouldn’t have the federal government mandate that an individual has to have health insurance, whether he or she wants it,” Mr. Barton said. “We want to repeal today so that we can begin to replace tomorrow.”

Representative Allyson Y. Schwartz, Democrat of Pennsylvania, said she doubted that the Republican alternatives would be effective in expanding coverage or controlling costs.

“Many Republicans want to repeal the law, but are not serious about replacing it,” Ms. Schwartz said.

Liberal Democrats in uproar over Libya action

A hard-core group of liberal House Democrats is questioning the constitutionality of U.S. missile strikes against [Libya](#), with one lawmaker raising the prospect of impeachment during a Democratic Caucus conference call on Saturday.

Reps. Jerrold Nadler (N.Y.), Donna Edwards (Md.), Mike Capuano (Mass.), Dennis Kucinich (Ohio), Maxine Waters (Calif.), Rob Andrews (N.J.), Sheila Jackson Lee (Texas), Barbara Lee (Calif.) and Del. Eleanor Holmes Norton (D.C.) “all strongly raised objections to the constitutionality of the president’s actions” during that call, said two Democratic lawmakers who took part.

Kucinich, who wanted to bring impeachment articles against both former President George W. Bush and Vice President Dick Cheney over Iraq — only to be blocked by his own leadership — asked why the U.S. missile strikes aren't impeachable offenses.

Kucinich also questioned why Democratic leaders didn't object when President Barack Obama told them of his plan for American participation in enforcing the Libyan no-fly zone during a White House Situation Room meeting on Friday, sources told POLITICO.

And liberals fumed that Congress hadn't been formally consulted before the attack and expressed concern that it would lead to a third U.S. war in the Muslim world.

While other Democratic lawmakers have publicly backed Obama — including House Minority Leader **Nancy Pelosi** (D-Calif.) and top members of the Armed Services, Foreign Affairs and Intelligence committees — the objections from a vocal group of anti-war Democrats on Capitol Hill could become a political problem for Obama, especially if “Operation Odyssey Dawn” fails to topple Libyan leader Muammar Qadhafi, leads to significant American casualties, or provokes a wider conflict in the troubled region of North Africa.

(Pelosi did not participate in Saturday's call; she is in Afghanistan to meet with U.S. military and diplomatic officials.)

U.S. warships fired more than 100 Tomahawk cruise missiles on Saturday in a bid to knock out Libya's air-defense systems, targeting command-and-control and radar units near Tripoli, the Libyan capital, and the city of Misurata, according to Pentagon officials and media reports. French aircraft attacked armored units loyal to Qadhafi around the city of Benghazi after they ignored international calls for a cease-fire.

Saturday's conference call was organized by Rep. **John Larson** (Conn.), chairman of the Democratic Caucus and the fourth-highest ranking party leader. Larson has called for Obama to seek congressional approval before committing the United States to any anti-Qadhafi military operation.

“They consulted the Arab League. They consulted the United Nations. They did not consult the United States Congress,” one Democrat lawmaker said of the White House. “They're creating wreckage, and they can't obviate that by saying there are no boots on the ground. ... There aren't boots on the ground; there are Tomahawks in the air.”

“Almost everybody who spoke was opposed to any unilateral actions or decisions being made by the president, and most of us expressed our constitutional concerns. There should be a resolution and there should be a debate so members of Congress can decide whether or not we enter in whatever this action is being called,” added another House Democrat opposed to the Libyan operation.

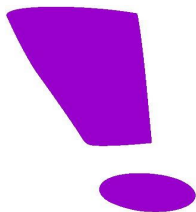

THE TEA PARTY PROPOSES BARE-BONES SKELETON BUDGET STRATEGY AND CUTS

TO THE FOLLOWING 12 AGENCIES/PROGRAMS TO RECTIFY THE DEFICIT:

1. DFACS - state should be in total control under the Governor/Feds should have no control or appropriated funding for this entity, no borrowing from the federal government to keep this running
 - the state needs to trade the cost of immigration enforcement for DFACS, meaning federal appropriations are to be used to enforce immigration laws only, not fund DFACS.
 - Clayton County DFACS should be audited for their reluctance or unwillingness to adhere to 30 day inquiry/complaint resolution within 60 days.
 - Spalding County DFACS should have funding cut for refusal to investigate and cooperate with other agencies.

(this is like the difference between civil and military matters, and the funding should be viewed as such that which takes precedence.)

2. SNAP - is an intrusion into state finance with a federally funded food subsidy

- too easily received food stamps/not readily taken away
- food stamps are being traded for drugs
- food stamps are being sold for cash
- DFACS is not assisting or abiding by laws and reporting and wasting our tax dollars, won't accept related emails regarding cases or individuals who receive child support.

3. PUBLIC BROADCASTING - NPR, PBS, etc.

- the federal government needs to get out of the media business!
- the federal government needs to govern and enforce laws, not indoctrinate, proselytize or garner political messages with tax dollars.

4. HOUSING ASSISTANCE and related reform:

- eradicate NACA and other groups that have a vested interest in the housing market that are receiving tax dollars to operate.
- FHA loans to resolve solvency issues, if you are current on your taxes.
- Prevent IRS fraud in the vulnerable mortgage market.
- FHA loan standards are stringent, other mortgage companies need to convert to these standards or be fined immediately.
- Go after Fannie Mae and Freddie Mac, fine them, and get the revenue back in the system for the damage done to taxpayers.

5. UNEMPLOYMENT CHECKS:

Last night, Speaker John Boehner addressed the Economic Club of New York and drew a line in the sand in the debt ceiling fight. It was a monumental game changer for the GOP and puts them back on offense.

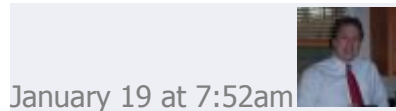

Property Tax Waivers

On or about February 2, 2009, the Henry County Tax Commissioner attended a BOC meeting and asked them to approve a resolution delegating authority to him to make a final determinations regarding the wavier of assessed penalties and interest on unpaid Ad Valorem taxes. The Tax Commissioner stated to the Board that he had an old lady that could pay her taxes, but could not pay the interest and penalties for being late. He also stated that he had a bank that inherited some land through no fault of their own. He said that he really wanted to help them. The BOC approved Resolution 09-18 approving the Tax Commissioner's request.

The following queries were sent to Tax Commissioner David Curry:

I am in receipt of the spreadsheet provided to Tommy Smith. I do have a question about some of the 6,148 entries. In residential developments I see a lot of individual addresses under the name of the developer. Are these houses that have not sold yet? I also see some rather large amounts waived for the same developers. Please give me some kind of response as I plan to raise queries in the newsletter -- I would rather have your direct explanation to accompany the article. Thanks for your help in understanding this spreadsheet.

David Curry's Explanation

Mr. Curry's response:

On December 10, 2010, Tommy Smith sent an open records request letter to Henry County. The request sought information concerning all penalties and interest that had been waived since February 2, 2009 from this office, Henry County Tax Commissioner's office. I answered his request and sent the information on February 21, 2010. Before I begin I would like to give a little background.

The authority to make the decision (O.C.G.A. 48-5-242) to waive penalties and/or interest is nothing new to Henry County nor is it different from most of the larger counties in Georgia. The past administration had an oral understanding it was okay to waive penalties and interest when he found it necessary. However, I did not feel comfortable making those financial decisions without having the support and written permission from the BOC. Therefore, on February 2, 2009 I stood before the Board of Commissioners, attendees, and the viewers of Channel 14 and asked for the authority to waive penalties and/or interest as I saw reasonably fit. Over the last 2 years there have been instances it was necessary to do so and I will explain in detail later in this e-mail. Since Mr. Smith received our response to his open records request there have been numerous e-mails sent back and forth and most of them reiterate my opinion, I believe Mr. Smith does not understand what he is reading. I want to address some of the language being used in the e-mails and some of the misconceptions.

First - **Never**, have I or this office waived taxes. Taxes cannot be waived. When taxes are due, it is the responsibility of this office to collect them. We use every available resource to do so (O.C.G.A. 48-5-234). When money was waived it was the penalty portion only and **not the tax portion**.

Second - Permission was given to waive penalty and interest. With that said I met with my leadership team and we discussed how we could help our taxpayers. I did not want to create a mindset that supported the idea of paying your taxes when you felt like it, however I vowed to help our taxpayers. We needed to have a plan to help while also promoted the idea everyone needed to pay their taxes on time.

While penalties and interest may have been waived prior to me taking office I decided it was in the best interest to all not to waive the interest portion of the bill. The interest is 1% monthly, 12% annually.

Third – On February 2, 2009, one of the commissioner's asked how I would determine who would or would not receive a penalty waiver. To be honest, this question was not easy to answer then nor is it any easier today. We look at each case separately. With that said, there are those instances where we simply cannot by law charge a penalty. We tried to explain that in our response to Mr. Smith but apparently it fell on deaf ears.

Here are some of the reasons we cannot charge a penalty.

1. FDIC collections (FDIC 12 U.S.C. 1811, et seq., section 15 of FDIA (d) – In 2009 we had a record number of local community banks fail in Henry County. When the FDIC came in, the assets were typically turned over to another bank, for example Regions, and the liabilities would be handled through the FDIC. As we all know 2009 was the worst year Henry County has experienced in a long time for builders and developers. Nearly every one of them lost their companies and the banks were forced to take back their inventory, land, and lots. Once the FDIC came in we were forced to play by their rules and not ours. Simply put the FDIC is the Federal Government and they do not pay penalties, only interest when secured by a lien.

2. Changes in Assessment from the Assessor's office – If it is determined there has been a mistake made in the assessment of a piece of property, for example, the property owner was being assessed for having 4 bedrooms and there were only 3 or if a land owner was assessed as having 20 acres and he/she really only owned 15 acres we would re-bill the owner with a new due date. Since the penalty goes on the bill 90 days past the original bills due date we often find ourselves re-billing after the 90 day period with a new amount owed. It can sound a little confusing; however, it is neither fair nor legal for me to charge a penalty on a bill that is incorrect. Once the assessment is correct, a new bill is issued and the penalty is applied if not paid within 90 days.

3. Postmark of payment submitted – We post payment according to the postmark. A lot of taxpayers wait until the last minute to pay their tax bills. As I mentioned in the above explanation, penalty is applied 90 days past due. If the postmark is on or before the due date and we receive it the next day we remove the penalty. At this point the taxpayer is paying the 1% interest each month the bill is not paid.

4. Certain Bankruptcy cases –

Under Bankruptcy court taxes are paid; however, depending on the type of bankruptcy filed we must get in line with the other creditors and wait our turn to be paid.

5. New Owner notification –

The Assessor's office must have a date in which they work off of; January 1 is the date. Often the current year's tax bill is sent to the owner on record as of January 1, 2010. By the time the tax bill is sent out in September the property may have been sold or foreclosed upon. If this is the case, once the assessor's receive the new address, we send out a new bill. Again, we cannot charge a penalty because the assessor's office does not have the new owner's address.

6. Appeal Resolutions –

It appears many of those selected in your e-mail were either paid by a bank or an appeal had been resolved. Once the appeal is resolved we must wait until the file is given to us from the assessor's office. Often these are property tax bills that have been taken to Superior court. This process is very lengthy and once resolved, if the appeal resolution pre-dates the application of the penalty, we remove the penalty, as it is not applicable. Again if the bill is not paid within 90 days, the penalty is automatically re-added to the bill. Mr. Stanley I hope I have addressed your questions. In this sample list roughly two-thirds were from the same developer. As you can see from my response I worked with Mr. Jones as well as Wachovia to collect \$402, 837.63. We did however collect over \$58,000 in interest on these 156 parcels. We stuck by what I said I was willing to do. Wachovia and Mr. Jones have been told not to expect the penalty to be waived in the future. I stated earlier in this e-mail, we have a plan to help those willing to help themselves. We are desperately trying to do just that. I will share some other information we learned last month. We are audited quite often and as of last month Henry County has the best collection rate of personal and delinquent taxes it has had in over 15 years. Our collection rate for 2009 is 96.50% for Personal property, 98.78% for Mobile homes, 97.22% for Real property. Our 2010 is also shaping up to follow 2009. I am very proud of the efforts made by this staff to collect delinquent taxes. I have placed explanations beside all of the entries. (** Spreadsheet sent to The Citizen) I truly hope this helps. This office has nothing to hide and has always offered an open door policy to anyone who has genuine questions and concerns. There is no "gatekeeper" here. If you have questions, I want you informed. I do find it disappointing that someone would ask for information from this office and not take the time to understand it or ask questions before sending it out to the masses. If anyone has any comments, questions, or concerns about this office or the information shared please do not hesitate to contact me. I am your Tax Commissioner and I am here to serve you.

Clayton police burn \$12M in drugs

Clayton County police burned more than \$12 million worth of drugs that had accumulated in the departments crowded evidence room, authorities said.

Police received a court order from a Superior Court judge to allow them to burn nearly 10,000 pounds of marijuana, crystal meth and other assorted

narcotics, Clayton County police spokeswoman Lt. Tina Daniel said.

"This is in response to the audit of the police department," Daniel said.

As part of a scathing indictment of former Police Chief Jeff Turner's management of the department, county Chief of Staff Alex Cohilas cited a narcotics evidence room that was "in shambles."

The burns happened on two different occasions, last week and Tuesday, in an undisclosed, secure location, Daniel said.

"This is just a small part of the police department's aggressive efforts to fight illegal drug use and sales in Clayton County," police chief Timothy Robinson said.

The burn was done with the aid of the Clayton Fire and Emergency Services, the Clayton County Sheriff's Office and the Clayton County District Attorney's Office.

The Methamphetamine 6 and the end of politics as usual

Voters in north Georgia had tired of politics as usual. They demanded something different.

Now they have it — a 9th District congressional race that, instead of ending on Tuesday, will go on and on like a painful but riveting summer soap opera.

The featured player is certain to be former state House member Tom Graves of Ranger, whose lush black hair, easy manner and tea party credentials made him the man to beat in a May 11 special election to fill out the final six months of former congressman Nathan Deal's term.

Former state House member Tom Graves of Ranger

Graves walked away with 35 percent of the vote. Odds are good that he'll win the Tuesday runoff against former state senator Lee Hawkins of Gainesville, a dentist.

Under normal circumstances, the fairy tale would end there. Graves' defeated opponents would gracefully exit — offering only token, underfunded resistance leading up to a July 20 primary and a full, two-year term in Congress. (No Democrat remains in the contest.)

But we are done with politics as usual, and have shifted to politics of the bizarre — courtesy of an extended-stay motel in Calhoun, nicknamed by its current proprietor as the Methamphetamine 6. In honor of the habits of its clientele.

At the crack of Memorial Day weekend, news broke of a lawsuit filed by the Bartow County Bank, which alleged that Graves and Senate Majority Leader Chip Rogers (R-Woodstock) had defaulted on a \$2.2 million loan used to purchase the establishment.

The business case for the Oglethorpe Inn is unclear. But Georgia offers some tasty tax breaks for on-scene movie companies, and perhaps a series of slasher flicks was contemplated.

The 32-year-old motel and debt, Rogers and Graves say, now belong to another company owned by a fellow who wears an electronic monitor on one ankle.

Moreover, Rogers and Graves accuse the bank of reneging on a deal.

The bank allegedly made a promise to two sitting state lawmakers — Graves resigned his seat this spring — that it would convert the obligation to a 2.5 percent, interest-only loan. On \$2.2 million.

A \$2.2 million loan was used to purchase this aging motel in Calhoun. Jeremy Redmon

Take a few minutes to sort through your mortgage checks and see how your bank deal compares.

The most damaging feature of the lawsuit is the bank's accusation that Graves fraudulently transferred two properties — including his residence in Ranger — to a trust in an attempt to frustrate the bank's efforts to collect on the debt.

Graves supporters say times are hard everywhere, but especially in north Georgia — where real estate has plummeted like a red-tailed hawk on a doomed pigeon.

Graves denies any wrongdoing. "This country has a judicial system in place where business disputes like this lawsuit can be successfully and fairly resolved," he said.

But the crucible of Washington is not famous for patience.

Assume a Graves victory next Tuesday. His supporters are enthusiastic, and last-minute developments rarely have a significant impact on campaigns.

Graves will be sworn in as soon as the vote is certified. Just as quickly, a complaint against him — third parties can be found, so the author

does not matter — will be lodged before a congressional ethics committee to force a speedy assessment of the facts.

Which means that regardless of what happens Tuesday, many of the combatants of the 9th District will refuse to leave the field.

Hawkins took 23 percent of the vote last month. In a statement issued Wednesday, the former senator would not concede defeat in next week's balloting . But he added this: "Mr. Graves has obviously used some very bad judgment in his financial dealings, and that controversy now apparently won't end on Tuesday regardless of who wins."

Likewise, Steve Tarvin of Dalton, a self-made textile executive, declared Graves' financial situation "unfortunate," but said he would not withdraw. Tarvin won 15 percent of the vote in May.

"I'm in it. I feel like I'm the true heart of the 9th District. I feel like in July, it's going to be a different story," Tarvin said. Of seven candidates who signed up for the July 20 contest, only two have said they would withdraw.

But none have sent the necessary notarized statement to Secretary of State Brian Kemp. As of now, all seven names will appear on the Republican ballot — a near guarantee that a runoff will push the soap opera into August.

The contest is already forcing signs of a split within Georgia's Republican delegation.

Graves has the support of U.S. Rep. Lynn Westmoreland of Coweta

County. But U.S. Rep. John Linder this week accused Graves of lying about the amount of campaigning he'd done on behalf of the Fair Tax.

Kate Monaghan, communications director for the Graves campaign, said her candidate expected a strong showing on Tuesday, equal to the vote in May. And she pointed out that U.S. Rep. Eric Cantor of Virginia, the House minority whip, endorsed Graves this week.

Monaghan singled out the dentist in Gainesville — the population center in the district is weighted toward that city — for criticism.

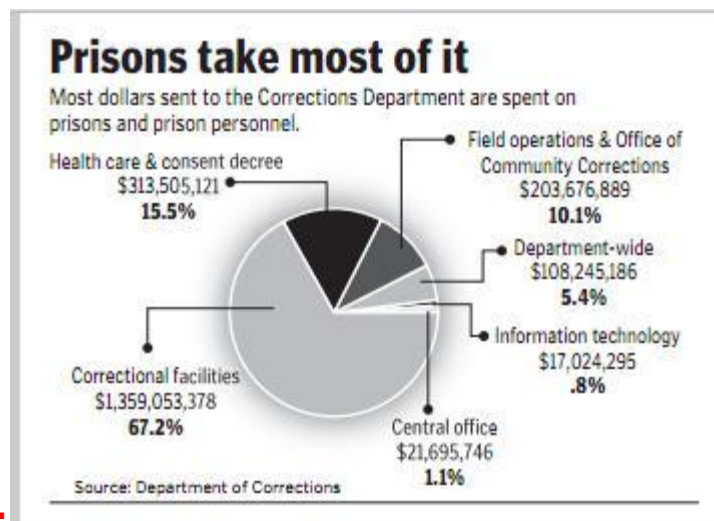

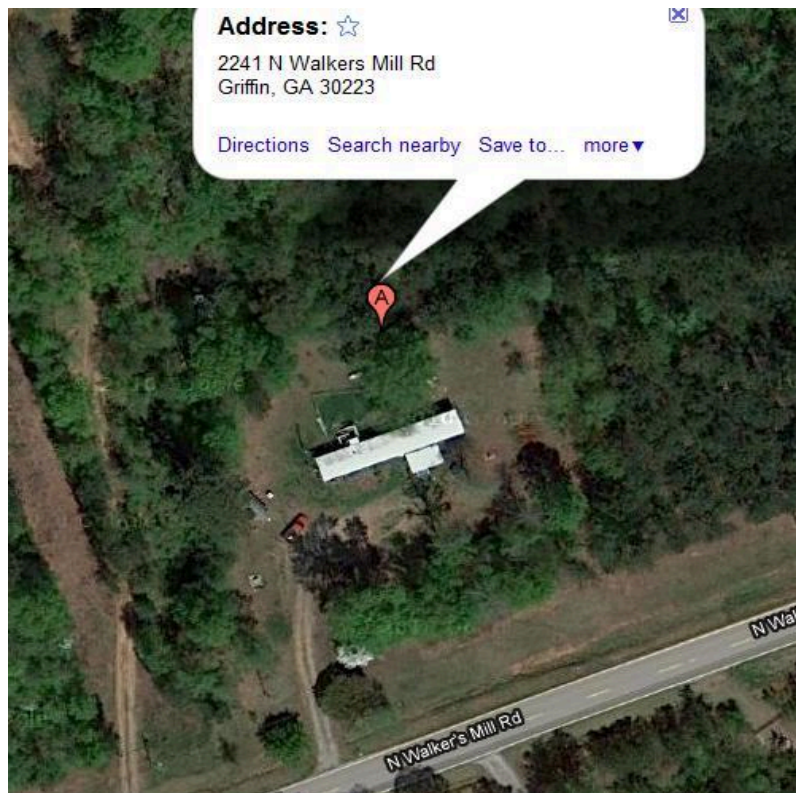

-Frankie Gibehart receives a Social Security check even though he works, and he receives food stamps, and he takes his brother Richard Gibehart's food stamps in lieu of rent or payment for drugs. Frankie is paying his

probation by these means, paying back the system with its own money.

-Carol Heybye was most recently incarcerated for 2 weeks in Henry County, then 30 days for failing to do her community service as ordered by the court/was cited for improper tag, no license, no insurance.

-They have been known to consort with crack cocaine dealers (named [REDACTED]) and do prescription pills. Someone overdosed in their home. 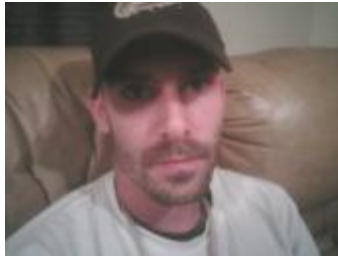

13-Year-Old Says Wind Pulled Her Out Of House, Flung Outside

Thursday Mornings Storm Destroyed Spalding County Home

GRIFFIN, Ga. -- An EF-3 tornado hit Spalding County and that's where an incredible story of survival comes for the daughter of a sheriff's deputy. The walls came down around the 13-year-old and the wind literally pulled her out of her home.

"It just kind of turns your stomach to see this because not even 24 hours ago everything was fine, everybody was happy," said the girl's brother, 16-year-old Corey Peavy.

Everything changed in an instant for the Peavy family. As they sift through what's left, they recall what happened.

“By the time I heard the noise, it was too late. We didn't have enough time,” said mom Stacey Peavy.

The storm early Thursday morning decimated their house. The roof ripped off, walls fell down and their van was bulldozed by the winds. The family said the scariest moment came when 13-year-old Kylie was flung outside.

“My windows started busting open and my wall like, like, fell over,” said Kylie Peavy.

“When I got into her room and the walls went up, I yelled for her and I just heard her scream, ‘Mommy, mommy,’” said Stacey Peavy.

“And I just got like, slung out. When I fell outside, everything started falling over and it was a whole bunch of stuff,” said Kylie Peavy.

Stacey said she somehow pulled Kylie inside.

“We got to my husband because he couldn't get to us and we hid in our closet and waited,” said Stacey Peavy.

When the storm passed, their home was unrecognizable. Corey Peavey said despite losing his home, he's thankful.

“It was a miracle my sister came out, I mean I was scared she wouldn't,” said Corey Peavy.

“We're hanging in there. All of it can be replaced, my kids can't,” said Stacey Peavy.

WE WILL KEEP ALL OF THOSE FAMILIES THAT LOST THEIR LOVE ONES IN THIS HORRIBLE WEATHER!! WHEN YOU THINK YOU GOING THRU ALOT SOMEONE OUT THERE IS GOING THRU WORSER!!!
