Attendance Policy:

Students should come to class prepared to learn, work, and enjoy the experience of dance. We understand that dancers may have other commitments; however, it is critical for students to attend as many classes as possible. A dancer cannot miss every class for 2, 4, or 6 weeks and expect to maintain or improve their skill level. Missing multiple classes is not appropriate and can be dangerous to the dancer.

Arrival and Pick-up:

Please have students arrive in a timely manner in order to be ready when class starts. Due to the progressive nature of the classes, and the required warm-up to prevent injury, students arriving more than twenty minutes late will not be allowed to participate. Please only use the front parking lot. You may use the back to turn around only. *****Please DO NOT leave children unattended at New Motions Dance Center. If your child is in class you may leave and return for pick-up. Siblings and friends (not in a class) may not remain here without an adult.***

Holidays and Closings:

New Motions Dance Center will close for: Halloween, Thanksgiving, Christmas, Easter, and Memorial Day. Classes **will** still be held on other holidays such as: Veteran's Day, Presidents Day, Martin Luther King Day, Columbus Day, and school conference or professional days.

Weather Closings and States of Emergency: New Motions Dance Center will follow the Queen Anne's County School System for weather and states of emergency closings. If schools close early, cancel after school activities, or are closed for the day, we **will not** have class. If schools open late, we **will** have class. If a child misses class due to an unforeseen closing or sickness, they may make it up by attending another class, as long as it is cleared ahead of time with instructors.

Dress Code:

Ballet: No baggy clothing is permitted. If needed, students may wear leg warmers, fitted turtlenecks, dance sweaters, etc. for warmth. **Leotards required.** Ballet skirts allowed. Pink or tan tights for class. Hair must be secured away from the face, preferably in a bun; ponytails and braids are also acceptable. Students will be given three weeks to obtain proper dancewear. If they do not have their leotard, proper footwear, and hair secured by the fourth week of class they may be asked to sit out. Skin tone tights will be worn for the recital.

Lyrical, Jazz, Hip Hop, Tap, Tumbling: Leotards, leggings, tights and spandex shorts are all acceptable. Jeans of any kind are not acceptable. This includes jeggings, jean shorts, overalls, etc.

Footwear:

Ballet - Girls: Pink/SkinTone leather slipper for Kinderdance, Pre Ballet I, and Ballet II. Canvas slipper for Ballet III - V. Boys: Black slippers

Lyrical + Contemporary - Socks, bare feet, footundeez, or skin tone canvas half soles.

Jazz - Girls: Tan, slip on jazz shoes. Boys: Black, slip on jazz shoes.

Hip Hop - CLEAN Black Sneakers with white or tan sole (Pastry shoes, DCs, Vans, Converse, etc.) NO shoes that have been worn outside

Tap - Black, tap shoe

Tumbling: Bare feet

No dangling earrings, necklaces, or bracelets. Small earrings, rings, and watches are permitted.

General Studio Policies:
