Dear Chairman Smith and Ranking Member Neal –

As the Ways and Means Committee marks up their budget reconciliation legislation this week, the **365** undersigned organizations urge you, and the members of the Committee, to protect and maintain full funding for the Social Services Block Grant (SSBG) by supporting Amendment **[insert #]** to strike the elimination of SSBG from the reconciliation bill.

Our coalition represents a diverse array of stakeholders, including associations of state and local governments and non-profit organizations representing the interests of children, older adults, people with disabilities, and vulnerable families - each organization believes that SSBG is vitally important to meeting the needs of children, families, and individuals in our communities.

SSBG was created in 1981 during the Reagan Administration, capping entitlement funding and turning it into a flexible block grant for states. Since 2003, SSBG has been funded at \$1.7 billion, and state and county governments use these funds to support 29 different types of human service programs. These services include protecting children, older adults and people with disabilities from abuse and neglect, adult day care and foster care, child care, in-home support, as well as both home-delivered and congregate meals. SSBG funding is also a source of assistance for many support services to youth and juveniles, including counseling and independent living services. SSBG and its flexibility helps state and local governments address gaps or shortfalls in many program areas and helps communities better serve their families.

SSBG funds serve millions of children, families and adults who are vulnerable, ranging from infants and toddlers to older adults. In 2022, the most recent federal SSBG data available, states reported just over 20 million recipients of SSBG services throughout FY 2022. Of the total, 9.2 million (46%) were children and 11 million (54%) were adults.

State and local governments have relied heavily on SSBG dollars to meet the unique needs of their communities; we have included a number of examples and anecdotes below. States and counties would be hard-pressed to replace lost SSBG funds if the grant were to be cut or eliminated, resulting in serious consequences for millions of children, older adults, and people with disabilities. Therefore, we strongly encourage you to protect funding to this critical source of support for children, individuals, and communities by supporting the amendment to strike mention of SSBG from the Ways and Means reconciliation bill.

State & Local Examples:

Georgia: SSBG funds are used to support critical Adult Protective Services (APS) functions including intake staff and travel reimbursement for home visits. Intake staff process calls from reporters, web reporting, and fax reporting as well as providing resources to the caller. These staff members are the first touch point many have with APS and losing staff would be a detriment to the program.

Hawaii: SSBG funds are critical for the State of Hawaii's Adult Protective and Community Services program. These funds are used to staff essential positions investigating abuse to vulnerable adults and as well as for important training for a highly skilled workforce.

Indiana: REAL Services, Inc. serves 30,000 older adults in Northern Indiana. They provide Home and Community Based Services to 49 clients through SSBG. Nearly half of these older adult clients are at a high nutritional risk, and 98% of all clients have at least one critical need that is being met by this program. Without SSBG funding, REAL Services would not be able to serve Home Delivered Meals to their homebound clients.

Michigan: Nearly a quarter of APS staff are funded by SSBG. The state budget would not be able to absorb the loss and vulnerable adults would be placed at higher risk. APS has only recently been elevated in importance in the state and loss of SSBG would cripple all gains.

Minnesota: Brown County uses SSBG funds to fund child welfare services, APS, services to individuals with disabilities and child care. According to the county, there is no other source of state or local funding that could cover the loss of SSBG dollars, and therefore, services would have to be reduced or eliminated. In Chippewa County, Minnesota, SSBG serves similar functions. If eliminated, the county would have to absorb the \$310,000 that this covers for helping provide services that keep its most vulnerable populations safe. This would cost the county another 2.5 percent increase on the county levy, representing a significant financial burden for the small rural county. Stearns County, Minnesota would also be forced to reduce services (including APS, child welfare, and services to individuals with disabilities) for nearly 6,000 county residents, with older adult residents in the county facing possible institutionalization due to the loss of in-home supports.

Missouri: One of the ways that Missouri uses SSBG is to fund adoption and foster care programs throughout the state, serving nearly 25,000 children each year through these programs. The MO Department of Social Services noted that loss of SSBG funds would be “catastrophic” for these foster care and adoption programs, as the state would not be able to make up the funding and would have to make significant cuts to programs.

New Jersey: In federal FY25, New Jersey received \$43.3 million in Social Services Block Grant (SSBG) to fund case management for children and families involved in the child protection system and in adoptions. It also funds staff salaries, building security and general maintenance. Without it, New Jersey could be working with fewer case managing staff, which could mean caseloads that exceed our state law, fewer home visits, less support for families’ reunification, longer periods of foster care, less secure facilities for staff and higher staff turnover due to burn-out.

Ohio: United Senior Services (USS) provides over 30 services to 4,000 members and 3,000 clients across Clark County. SSBG funding makes it possible for USS to offer 909 congregate meals and nearly 2,000

Home Delivered Meals. A loss of SSBG funding would result in a one-month service interruption at three of their congregate meals sites and would cut 1,740 Home Delivered Meals.

Ohio: Wayne County uses SSBG funds to support Adult Protective Services (APS) and child welfare, as well as adult senior day care services, home-based services for seniors, support for a domestic violence shelter, case management for at-risk youth in schools, and transportation services for individuals to and from dialysis and chemotherapy. According to the county, SSBG is one of the few revenue streams that allows it to serve certain populations of vulnerable adults, and many senior services would be curtailed or terminated without this funding stream. Similarly, Miami County, Ohio relies on SSBG to support the provision of mental health services at a counseling center, legal services for women and children who are fleeing DV situations, and a Family Abuse Shelter, along with services to individuals with disabilities, APS and child welfare services. There is no other source of state or local funding to cover the elimination of those dollars.

Pennsylvania: Erie County, Pennsylvania uses SSBG funds for mental health administrative case management. Without these funds, the county would face a 25 percent reduction in its funding for these services, which coordinate supports for roughly 1350 individuals. Similarly, Crawford County, Pennsylvania uses its SSBG allocation to support in home community habilitation services for individuals with intellectual disabilities and to support mental health services at the county drop in center, which saw a caseload of 743 individuals in 2024.

South Carolina: SSBG has fully funded the APS program. Losing this funding would be devastating and the nearly 6,000 vulnerable adults served every year would be negatively affected. In one case, SC APS was involved in a case where a 71 year old veteran who was a double amputee faced severe caregiver neglect. APS was able to get a deep cleaning of the home and make needed structural repairs for accessibility. They were also able to connect her to Veterans Administration benefits and support her son as a caregiver. Not only did this allow the veteran to remain in her own home it brought significant savings through reduced EMS calls and prevention of the need for state assistance. Without SSBG, vulnerable South Carolinians would not have these same services.

Texas: Meals on Wheels Plus, Inc., which serves 1,738 clients in Abilene, TX and an additional 14 small rural communities across five counties in central Texas, depends on SSBG funds for nearly half of its total budget. This organization does not receive any other federal dollars and experienced a significant funding shortfall last year, with SSBG funds covering meals for only one thousand of their clients - leaving three hundred individuals on a waitlist to receive critical services. Elimination of SSBG funding would not only be catastrophic for Meals on Wheels Plus and the older adults they serve, but for impacted Meals on Wheels providers across the country.

Wisconsin: SSBG funds are included in Community Aids – flexible funding streams for county governments that can be used for child welfare, behavioral health, disability services and adult protective services. Statewide, SSBG funds serve 86,000 children and 37,000 adults. Eliminating SSBG would represent a significant cost shift to county governments in Wisconsin, leading to a reduction in services.
