Subject: Urgent Concern: Lack of Post-19 Support for Adults with Complex Needs in Northern Ireland

Dear Minister / Committee Clerk,

I am writing as the parent of a young person with complex learning disabilities. Like many other families in Northern Ireland, I am deeply concerned about the complete lack of structured, legally protected post-19 support for individuals with severe learning disabilities.

Without a dedicated post-19 framework, young people with the highest support needs are being systematically excluded from adult services. Those with complex behaviours or high dependency are often the very individuals left without any access to provision. This forces families into crisis and places enormous strain on health and social care systems.

It is not acceptable that in 2025, families are still being left to fight alone for access to basic support. We need urgent cross-departmental leadership to address this growing inequality.

I support Caleb Cause NI's calls for:

1. A dedicated Post-19 Framework for Northern Ireland, with statutory protections and funding for young adults with complex needs.
2. Clear departmental accountability, including Economy, Health, Education, Communities, Justice and Infrastructure, ensuring no young person is abandoned after school.
3. Transparent and fair funding.
4. Inclusion of parent and carer voices in all planning and oversight of post-19 provision.

This issue affects every special school in Northern Ireland. The lack of clear guidance, provision, and oversight is not just a policy failure, it is a safeguarding risk.
