

RVUSD QUEST ENRICHMENT ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT

(ONLY FOR FAMILIES OF NON-RVUSD STUDENTS - please submit on the first day of Quest)

I understand and agree as set forth below.

My child or children are voluntarily participating in an on-site summer program offered by Rincon Valley Union School District. ("RVUSD"); RVUSD, its governing board, officers, employees, volunteers, instructors and independent contractors (collectively "Released Parties") shall not be liable for any injury or illness suffered by my child(ren) which is related to or arises out of their participation in RVUSD's Quest Enrichment, their presence on RVUSD property, or their use of the District facilities, and to the fullest extent allowed by law, on behalf of my child and myself, I voluntarily assume all known and unknown risks of injury or illness, howsoever caused, even if caused, in whole or in part, by the action or inaction of the Released Parties;

The Released Parties shall not be liable for any bodily injury to or death of persons, or damage to property, sustained by my child or children's participation in the RVUSD's Quest Enrichment, presence on the District property, or use of the District facilities, that is caused by any act, neglect, default, omission, or liability of my child or children" except for liability, loss or damage attributed to the negligence or willful misconduct of the Released Parties.

My child or children's participation in RVUSD's Summer Quest, presence on the District property, and use of the District facilities include possible exposure to, illness, and death from infectious diseases including, but not limited to, methicillin-resistant Staphylococcus aureus (MRSA), influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; I knowingly and freely assume all such risks, both known and unknown, and assume full responsibility for my child's or children's participation in the District's Program presence on the District property and/or use of the District facilities; I willingly agree to comply with the stated and customary terms and conditions for participation as they relate to protection against infectious diseases.

To the fullest extent permitted by law, I, for myself, and on behalf of my child(ren), heirs, assigns, and representatives hereby release and hold harmless the Released Parties with respect to any and all illness, injury, disability, death of my child(ren) related to or arising out of my child or children's participation in RVUSD's Quest Enrichment, presence on the District property or their use of the District Facilities.

I HAVE READ THIS WAIVER OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT. I FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY.
