## Examinations

*Summary: The state, and for that matter, all states, require demonstration of professional competencies in Pre-Professional Skills (PRAXIS Core, ACT/SAT, or academic classes), content knowledge (PRAXIS Content Knowledge), and teaching (EdTPA). For all tests, be sure to have scores reported to WVU.*

### Satisfying Pre-Professional Skills Requirements

The requirements for Pre-Professional Skills can be satisfied by any combination of methods listed in this table:

\*ENG 103 can be counted toward Reading OR Writing, but not for both.

#### Other possible exemptions:

AP Scores, so long as it is accepted by WVU for related GEF credit, can count as satisfying Pre-Professional Skills.

In some instances, GEF 4, 5, 6, or 7 may satisfy the Reading requirement. This is determined on a case-by-case basis.

NOTE: There is a 28-day wait period before you can retake any portion of the PRAXIS Core exam.

### Content Knowledge

This requirement is satisfied by taking and passing the PRAXIS II Music - Content Knowledge (5113).

1. Passing score: 155

### Teaching

This requirement is satisfied by completing the EdTPA portfolio during student teaching. Information on this portfolio will be discussed in Student-Teaching Seminar.

# **Field Experience Requirements**

*Summary: You must complete 125 hours of clinical experience (field observation or teaching) prior to student teaching.*

## **Field Hours**

The West Virginia Department of Education requires candidates to complete 125 hours of clinical experience in the field. 34 of these hours are completed through coursework as follows:

- MUSC 191/180: 4 hours (beginning Fall 2024)
- MUSC 380: 6 hours
- MUSC 381: 6 hours
- MUSC 382: 14 hours
- SPED 460: 4 hours

Students are required to complete the remaining 95 hours on their own time. 62.5 of these hours can be virtual/asynchronous. All hours must be completed with a teacher certified to teach in the state in which the observation occurs.

## **Reporting Field Hours**

Students are required to keep track of their own field hours. All hours (in and out of coursework) must be logged here: <https://www.cognitofrms.com/WestVirginiaUniversity2/SchoolOfMusicMusicEducationClinicalHours>

## **Background Check**

All students with field-based or pre-student teaching experience must have evidence of a criminal background check with digital fingerprinting before entering a school/daycare center/preschool/etc. The school systems/centers require that you always have the background check results with you and can provide them when asked.

7. Answer Personal Questions, Click Next
8. Enter additional personal information, Click Next
9. Enter mailing address where you would like your results to be sent, Click Next
10. Choose the appropriate identification document you will bring to the appointment (A Driver's License is the most common form of identification used.), Click Next

12. Enter your zip code for the location of the appointment you are seeking, Click search, choose a location generated by the search, Click Next
13. Select a date and time
14. Review Service Summary for accuracy, Click Done
15. You will pay the fee at your appointment. Current cost is \$34.00. Payment methods accepted: credit card, money order or check. NO CASH!
16. Allow up to 3 weeks for results.

Results are sent to you personally at your address, so use your West Virginia local address. Keep your results in a safe place. You will use them for more than one semester. Keep a copy with you when you go into your schools.

## Candidacy Application and Interview

Completing the Music Education Area Candidacy Application and Interview. The interview has two components: a demonstration of musicianship and a question-and-answer session. For the music demonstration, students will do the following:

- Record themselves...
  - Performing 2 children's songs:
    - 1 in a minor key
    - 1 in either dorian or mixolydian.
    - Go [here](#) to see the song choices.
    - One of the above song choices must be accompanied on either guitar or piano (using broken chord accompaniment)
  - Singing a major and minor (natural or harmonic – student choice) scale and arpeggio.
  - All recordings should be done in “one take”

At the interview, students will perform a 2-minute excerpt from their jury (unaccompanied) on their primary instruments and answer questions.

## Candidacy Decisions

One of four decisions will be made regarding the student's admission to candidacy.

1. Admitted – Student has been admitted to candidacy and may register for methods coursework.
2. Admitted Pending – Student has been admitted to candidacy pending the completion of current coursework. All other requirements must be met for students to be Admitted.
  - a. Pending unmet requirements (e.g completing a proficiency for a class in which you are currently enrolled)
  - b. Pending meeting with advisor
3. Denied – Student has been denied admittance and must wait a semester to re-apply and interview.
  - a. Examples of reasons for denial
    - i. Multiple failed proficiency results

- ii. Unmet GPA requirement (overall, core music, and professional education)
  - iii. Prerequisite course(s) missing and/or not scheduled
- 4. Deferred – Student has an unmet requirement that must be resolved by noon the Friday before classes begin in order to enroll in methods coursework. In cases of deferral, it is the student’s responsibility to address the deficiencies by the deadline stated.
  - a. Examples include:
    - i. Outstanding proficiency exam from previous semesters
    - ii. Coursework scheduled, but not yet taken and passed

## WVU Music Education Area Attendance Policy

An important component of a teacher's disposition is regular attendance at their job. As such, all music education students are expected and required to attend all lecture and lab sessions, bring relevant equipment and materials, and fully participate in their own learning. Just as a teacher reports absences to their building supervisors in order to secure substitute teachers, WVU music education students will be expected to communicate all absences with the course instructor, in advance when possible.

### Absences

The instructor has sole discretion to either excuse or not excuse an absence. Students must communicate with the instructor regarding ALL absences.

*Excused absences:* An excused absence allows students to make up quizzes, tests, time-sensitive assignments, or other course material covered on the day(s) of absence. They typically consist of: religious observances, physical or mental health issues (standard physicians or therapists note needed), SoM Sanctioned Functions, and military service.

*Unexcused absence:* An unexcused absence may, at the discretion of the instructor, result in students not being allowed to make up quizzes, tests, time-sensitive assignments, or other course material. They typically consist of physical or mental health issues without a standard physician's or therapist's note, traffic-related tardiness, oversleeping, and skipping.

### Sanctioned functions and absences

Students who participate in official functions sanctioned by the School of Music may **request to be excused** from class for such official functions by following these guidelines:

- Request, in-person or via email, to be excused on the dates of the sanctioned function at least two weeks before the sanctioned function
- Requests will only be considered after instructors receive the official approval of the sanctioned event from the Director of the School of Music or their designee.
- Follow the instructions of the course instructor regarding make-up work/quizzes/exams/etc,
- **The instructor maintains sole discretion when excusing (or not) an absence for sanctioned function.** Such decisions will be made on a student-by-student basis.

### Inclement weather and other emergencies

In the event of inclement weather or other emergency the university may implement a university-wide closure. In instances where this does not occur, the decision regarding class cancellation is left to the course instructor. Check your MIX email and eCampus for information directly from the instructor. In all circumstances, assume class will occur as scheduled unless otherwise notified by the course instructor.

Never assume an absence is excused. Sending an email informing the instructor of an absence does not constitute a request to be excused. Requests are typically presented in the form of a question.

## Lab attendance

If a student receives an F in a lab based on the attendance policy above, the pedagogy or methods course grade will be reduced by one full letter grade.

## Other Attendance Policies

- The overwhelming majority of course content must be experienced in class and cannot simply be “made-up” when a student is absent, regardless of whether the absence is excused or unexcused. As such, any absences (excused or unexcused) totaling 11% will result in failure of the course.
- Students who attend class unprepared (i.e., lacking books/materials or without having completed homework or assigned reading) will be considered absent (unexcused).



# **School of Music Undergraduate Academic Progress**

Approved by the Music Faculty - April 2, 1992

The Music Faculty has adopted this statement on academic progress in music courses so that students complete a degree program in a reasonable period of time. Full-time undergraduate music students are expected to complete in a timely fashion the "core" music classes, as follows:

Students who do not meet these expectations will receive a letter of warning at the end of the relevant semester. Students who fail or withdraw from any one of these courses must pass it the next time it is offered. Any student who does not complete these courses with passing grades within one year of schedule will be dismissed (suspended) from the music program, unless there are compelling extenuating circumstances.

### *Core Music GPA (min. 2.75)*

Students must earn and maintain a grade point averages of 2.75 each semester. If any of the three GPAs (overall, Professional Education, or Core Music) fall below 2.75, the student will receive a warning. If the GPA is below 2.75 a second consecutive semester, the student will be not be permitted to continue in the Music Education. Major

## **Principal Instrument Requirements**

- Each student is required to register for applied lessons on his or her principal instrument every semester he or she is enrolled as a music student (excluding the semester he or she student teaches).
- Each student is required to participate in a music ensemble every semester he or she is enrolled as a music student (excluding the semester he or she student teaches).
- Each student is required (at minimum) to present either a half recital or two separate solo performances on his or her major instrument on two upper-level Music Convocation's prior to student teaching. Applications to perform on an upper-level recital may be obtained from the School of Music office. Upon a successful performance, a copy of the upper-level recital program will be placed by the Instructor of Music Convocation in the student's permanent file in the CCA Records office.

## Secondary Instrument Proficiencies

*Summary: Students take proficiency exams on secondary instruments during pedagogy classes. All instruments must be passed before students can student teach. Some proficiencies are required before entering candidacy.*

- Students enrolled in a pedagogy class (MUSC 280, 281, 282, 283, and 284) must take and pass proficiencies on their assigned instruments.
- Proficiencies are graded as part of the Pedagogy Course.
- The first attempt at the proficiency will be the grade of record regardless of the number of subsequent attempts.

### Proficiency re-takes

1. First re-takes must occur during the semester in which the proficiency was failed.
  - a. Exception: Any proficiency administered during the last week of class.
  - b. You only perform the items which were deemed deficient
  - c. Does not affect the grade in the pedagogy course.
2. Second re-takes must be completed by the end of the semester following the failed proficiency.
3. Proficiency re-takes occurring longer than one semester following the failed initial proficiency:
  - a. You must perform the entire proficiency regardless of pass/failed section
  - b. Do not affect the grade in the pedagogy course.
4. To schedule a retake you must contact the current instructor for the course/module.

## **Music Education Area Double Major and Double Emphasis Policy**

It may be possible for a student to pursue an additional (second) major or emphasis. Approval to add a second major or emphasis is by written consent of the Coordinator of Music Education after the student has completed a minimum of two semesters in the first major or emphasis. An optional program can be arranged for outstanding students who desire to meet the requirements of majors in both performance and music education. Admission to this rigorous program is by written consent of the coordinator of the appropriate performance area and the coordinator of music education after the student has completed two semesters.

## **School of Music Secondary Applied Study Policy**

In rare cases in which a student is proficient in two different performance media, it is possible to pursue applied study on the second medium. The student must audition and be accepted on the principal medium and must also audition on the secondary medium. If the audition on the secondary medium is acceptable, the student will be permitted to study both principal and secondary media (pending studio availability) with the understanding that the initial designation of the principal medium and the secondary medium is permanent.

In extraordinary circumstances in which a student is highly proficient on both performance media, the student may petition to the Director of the School of Music to declare a “double principal.” This petition may be made only after a minimum of two successful semesters of applied study on both performance media. Approval of this declaration requires the unanimous support of both applied instructors and the coordinator of the student’s degree program. If the student’s degree program is the BA in Music or the BM in Performance, the Director will designate a Coordinator in addition to the applied instructors to participate in the review of the petition.

## **Appeals Process**

In the event a student wishes to appeal a decision (e.g. GPA dismissal or candidacy decision) they must submit, via letter (emailed as an attachment) a formal request to the Coordinator of Music Education.

- The letter should include:
  - A statement formally requesting an appeal of the decision.
  - A brief explanation of the reason for the concern noted in the dismissal/denial and any unique circumstances that may warrant an appeal.
  - Specific steps that will be taken to address the concerns stated in the dismissal/decision letter.

The music education coordinator will next present the appeal to the music education faculty. The faculty will consider the request and reach a decision. The student will receive the decision within a week of submitting the letter of appeal. Should the decision be upheld, the student may submit an appeal to the Director of the School of Music within two days using the same process outlined above.

## **Student Teaching in Music Policies and Procedures**

The role of a teacher is that of a professional and carries with it immeasurable responsibility, liability, and reward. The role of a student teacher is that of an intern, one who is practicing and being guided through the many facets of professional teaching. The importance of either role cannot be overstated.

In such a role, student teachers can expect:

- to devote full-time efforts to student teaching, including participation in after-school, evening, and weekend events. Student teaching responsibilities take precedence over all other commitments;
- to gradually assume teaching responsibility, ultimately carrying out the workload that is required of the cooperating teacher to whom he or she is assigned;
- to receive instruction and critiques on his or her performance for professional growth and development, and to improve his or her professional performance accordingly;
- to receive no compensation for his or her work since student teachers are receiving invaluable opportunities, mentoring, and training;
- to meet the challenge of his or her role with the professionalism and maturity expected of anyone deserving certification within the music education profession.

### **Requirements To Qualify for a Student Teaching Placement**

- an overall GPA of 2.75 in all courses taken at WVU and any other institution (including courses taken at other institutions that are not accepted by WVU)
- a GPA of 2.75 in all music courses, with no Ds or Fs in MUSC 138, MUSC 200, MUSC 201, MUSC 202, or MUSC 384
- a GPA of 2.75 in all professional education courses, with no Ds or Fs in MUSC 180, MUSC 280, MUSC 281, MUSC 282, MUSC 283, MUSC 284, MUSC 380, MUSC 381, MUSC 382, EDUC 301, SPED 304, SPED 360, or RDNG 422
- Students must have passed all sections of the Praxis II: Music - Content Knowledge Exam.
- Students must be on track regarding their curriculum/studio recital requirement on their principal instrument.
- Students must have passed all required proficiency exams.
- Students must meet all of the above requirements by week 3 of the semester prior to the semester in which they intend to student teach (fall semester for spring student teachers, spring semester for fall student teachers). Students who fail to meet any of the above requirements by the mid-term deadline will not be given a student teaching placement and will be delayed in their student teaching by a minimum of one semester (not including summer). Students for whom student teaching will be delayed will have the opportunity to consult with Music Education faculty to develop a plan for addressing remaining requirements and any other relevant issues in order to attempt to qualify for student teaching in a future semester.
- Failure to meet any student teaching qualifying requirement between submission of the student teaching application and the beginning of the intended student teaching semester will result in immediate removal from student teaching. Full audits for all student teachers will occur at the end of the fall semester for spring placements and at the end of the spring semester for fall placements.

### **Student Teaching Application Process**

Students who plan to student teach must submit two student teaching applications in the academic year prior to the one in which they intend to student teach. The first application is submitted to Dr. Munroe; the second application includes

the permit application and is submitted to CAHS and WVDE. Both applications are available from Dr. Munroe. Students failing to submit either application on time cannot be guaranteed a teaching placement.

Students' preferences for either a fall or spring placement will normally be accommodated; however, a student may be advised to change semesters.

## Student Teaching Placement Process

Once a prospective student teacher has completed all requirements, the coordinator of student teaching in music initiates the process for securing a student teaching placement. Preliminary requests are made to cooperating teachers and administrators on behalf of each prospective student teacher in an effort to secure a placement that will satisfy the required levels (K-5; 6 -12).

Information about student teaching placements will be available to students through the coordinator of student teaching in music (normally in March for fall placements and in October for spring placements). Final confirmation of student teaching placements will be available in the Office of Field Experiences during finals week of the semester prior to student teaching.

## Placement Considerations

Several factors are taken into consideration when identifying appropriate student teaching placements:

- the student's goals and interests (as expressed on the music student teaching application)
- the student's demonstrated strengths and areas of concern
- the characteristics of the placement; e.g. size and type of program
- the expertise and expectations of the cooperating teacher
- the availability of the placement

Geographic location is not a consideration when securing teaching placements for students. Due to the limited number of music placements in the Morgantown area, students should be prepared to relocate or commute during the semester in which they student teach. (All teaching placements are generally within a 100-mile radius of Morgantown.) Students' requests for specific regions, school districts, or cooperating teachers will not be taken into consideration unless the student can demonstrate severe personal constraints. (Such constraints do not include lack of desire to leave Morgantown or inability to break a lease in Morgantown.)

Virtually all teaching placements require that students travel to two or more schools. Students must provide their own transportation.

## **Registering for Courses During Student Teaching**

Students will register for these 16 credits during the semester they student teach:

- MUSC 487 - Student Teaching Seminar-Capstone (2 credits)
- MUSC 491 - Professional Field Experience (Extended Learning course) (14 credits)

Students may not register for or participate in university ensembles, lessons, recitals, or courses during the semester in which they student teach.

## **Withdrawal/Removal from Music Education Degree**

If you withdraw from the music education program, you may apply for re-entry back into the program. If a calendar year has elapsed since your withdrawal, you will need to re-audition into the School of Music. Coursework previously taken will count towards degree completion if re-entry into the program occurs within 2 years.
