The purpose of this meeting is to conduct the business of the SSCO Board, which makes its decisions based upon the work of the committees, and to have committee chairs make their reports to the Board. Only Board members can vote on motions and when appropriate, motions can be opened to the floor for discussion. Discussions will follow parliamentary procedure.

Any person who wishes to be on the agenda for a Board meeting should contact the Board Chair in writing at <u>board@stevensquare.org</u> ten (10) days in advance of the next scheduled Board Meeting. The Executive Committee reviews all requests and prepares the agenda.

SSCO recognizes that name and gender identity are central to most individuals' sense of self and well-being, and that it is important for SSCO to establish mechanisms to acknowledge and support individuals' self-identification. One way we can support identity is by honoring the name and pronouns that each of us go by.

Many people might go by a name in daily life that is different from their legal name. In our gatherings, we seek to refer to people by the names that they go by.

Pronouns can be a way to affirm someone's gender identity, but they can also be unrelated to a person's identity. They are simply a public way in which people are referred to in place of their name (e.g. "he" or "she" or "they" or "ze" or something else). At all SSCO Board and committee meetings, you are invited (if you want to) to share what pronouns you go by, and we seek to refer to people using the pronouns that they share. The pronouns someone indicates are not necessarily indicative of their gender identity.

City of Minneapolis Land Acknowledgement: As we meet here today, we are reminded that Minneapolis is situated on the homelands of the Dakota people. An area that is steeped in rich Indigenous history, and today is home to Indigenous people from more than 30 different nations. As a City, we have a responsibility to care for the land on which we live and work and all of its natural surroundings. This stewardship is an integral part of our involvement in SSCO, and we honor it as we begin our meeting.

- Traffic Signal Improvement Project: Beginning this spring (estimated May 12, 2025), this project will be reconstructing traffic signal and curb ramp infrastructure at 8 intersections in its phase 1. These locations will be at LaSalle Ave at Grant St, Nicollet Ave at 15th St, Willow St at 15th St, Nicollet Ave at Grant St, Nicollet Ave at 18th St, LaSalle Ava at Groveland Ave, LaSalle Ava at 15th St, 3rd Ave at 18th St. Some highlights of the improvements within the project:
 - Aging traffic signals will be replaced by new traffic signals with improved signal visibility
 - ADA-compliant curb ramps at all corners
 - Accessible Pedestrian Signals (APS)
 - Curb extensions to expand the pedestrian space
 - Ped Refuge Medians
 - LED intersection lighting
 - Timeline: June 30th start date
 - Scheduled to be completed by September 8th


2025 Traffic Signal Improvements

The City of Minneapolis is leading a project which will deliver Traffic and Pedestrian Safety Improvements to 8 intersections in Loring Park, Lowry Hill East, and Stevens Square neighborhoods. Work will occur at the following locations in Ward 6 and Ward 7.



- Nicollet Ave at 15th St
- Nicollet Ave at 18th St
- LaSalle Ave at 15th St
- LaSalle Ave at Grant St

- Willow St at 15th St

Currently, City crews have installed temporary signals for operations during construction. Other construction impacts will include lane shifts/closures and some temporary access closures on the side streets at the project intersections. Pedestrian access will be always maintained throughout the project.

 Centerpoint Energy Upcoming Construction: Starting as early as Monday April 28th (Estimated 1 month). Upgrades to natural gas distribution in coordination with pavement project completed by Public Works.
