## **Everett Community College Hazing Report**

## **Hazing Reporting**

IHE must publish a report disclosing all student groups found responsible for engaging in hazing quarterly. The report must be published at least forty-five (45) days before the Fall quarter commences and at least ten (10) days before the start of any other academic quarter. The report must contain the beginning and end dates for the hazing investigation, the dates the student group was charged with hazing and the date it was found responsible for the violation, a description of the incident, and a description of the sanctions and the date they were imposed. Each report must be retained for at least five years.

The Act requires that the report comply with the Family Educational Records and Privacy Act (FERPA), which protects the confidentiality of personally identifiable student records. IHEs will want to confer with their assigned Assistant Attorneys General to ensure that disclosure made in compliance with the Act conforms with FERPA.
