

Saint Louis University Daily Crime & Fire Log Information

(Crime log for the SLU Main Campus and Scott Law Center)

The purpose of the daily crime log is to record all criminal incidents, and alleged criminal incidents that are reported to the Saint Louis University Department of Public Safety and Emergency Preparedness (DPS) and occurred within the Clery geographical boundaries of the SLU main campus and the Scott Law Center. Crime log case numbers do not run sequentially. DPS assigns a case number for all reportable activities, both criminal and noncriminal. Only case numbers generated for criminal activity are listed in the crime log and are listed in chronological order with the most recent crimes listed at the top.

According to Federal Law, an institution may withhold any of the required fields of entry, i.e. the nature, date, time, location and/or disposition if any of the following conditions apply:

1. The disclosure is prohibited by law
2. If disclosure would jeopardize the confidentiality of the victim.
3. If disclosure would jeopardize an ongoing criminal investigation or the safety of an individual
4. If disclosure would cause a suspect to flee or evade detection
5. If disclosure would result in the destruction of evidence

An electronic version of the most recent 60-day period is available on this web page. Hard copies of the logs are available at the DPS office, Wool Center, Room 114, 3545 Lindell Blvd, Saint Louis, MO 63103 or at the Scott Law Center campus, 100 N. Tucker Blvd, Saint Louis, MO 63101 during normal business hours. Any request for the logs that are older than 60 days will be available for on-site inspection within two business days of the request at the DPS office.

In the crime log, the number listed in parentheses in the nature/classification box is the number of crimes/victims/violators that occurred during that specific incident. For example, "Liquor Violation-Underage (6) means 6 students were referred to OSRCS for an underage liquor violation.

Note*: Incidents with a case number that start with "OSRCS" involve information received by DPS from the Office of Student Responsibility and Community Standards during our regular scheduled meeting. These are cases that were reported directly to them, usually via the Resident Assistants. In these cases, the incident was reported directly to that office and not to DPS, therefore, it is not always possible to provide information regarding the five areas typically covered in the Crime Log, i.e. Nature/Classification, Date Reported, Date Occurred, Time, General Location, and Disposition. Because an official report was not filed, the disposition will be "Closed-Received from OSRCS". These incidents are reported to the DPS for statistical purposes and are posted to the Crime Log as the information is received by the department.

Note:** Incidents with a case number that start with "CSA " involve information received from other University administrators, who are defined by Federal law as "campus security authorities". These administrators share non-identifying information with the DPS that is provided by the victim. In these incidents, the crime was reported directly to that CSA and not DPS; therefore, it is not always possible to provide information regarding the five areas typically covered in the Crime Log, i.e., Nature/Classification, Date Reported, Date Occurred, Time, General Location, and Disposition. Because an official report was not filed, the disposition will be "Closed-Criminal incidents reported by a Campus Security Authority (CSA) as part of Clery compliance". These incidents are reported to the DPS for statistical purposes and are posted to the Crime Log as the information is received by the department.

Note*:** Incidents with a case number that start with "SLMPD " or lists another Law Enforcement Agency involve crimes reported directly to a local law enforcement agency, but not DPS. Because an official report was not filed with the University, the disposition will be "Closed-Criminal incidents reported by the St. Louis Metropolitan Police Department (or other Law Enforcement Agency) for inclusion in the (insert year) Annual Security & Fire Safety Report as part of Clery compliance". These incidents are reported to the DPS for statistical purposes and are posted to the Crime Log as the information is received by the department.

Note**:** Incidents with a case number that start with "Title IX" involve information received by DPS from the Title IX office. These are cases that were reported directly to them and not to DPS, therefore, it is not always possible to provide information regarding the five areas typically covered in the Crime Log, i.e., Nature/Classification, Date Reported, Date Occurred, Time, General Location, and Disposition. Because an official report was not filed, the disposition will be "Closed-Received from Title IX. These incidents are reported to the DPS for statistical purposes and are posted to the Crime Log as the information is received by the department.

Fire Log Information

DPS maintains a log of fires that have occurred in on-campus student housing in accordance with federal regulations (34 CFR §688.49). The fire log is NOT a complete list of all fire events that have occurred on University property, just fires that have met the required definition and occurred in an on-campus student housing only. **There is no fire log required for the Scott Law Center since we don't have residential halls on that campus.**

The following definitions apply to this fire log.

“On-campus student housing” refers only to structures containing residential occupancy for students. The fire log does not include neighborhood centers within student housing developments, campus facilities (administrative, academic, library, student life, or support) where students may stay overnight on a transient basis, vehicles, locations off University property, or outdoor locations of any kind.

“Fire” is defined as “any instance of open flame or other burning in a place not intended to contain the burning or in an uncontrolled manner.” “Fire” does not include controlled burning, even when that event is contrary to policy, such as candles, smoking, or other open flames, when that open flame does not result in property damage. -

<i>The following is an explanation of the terminology used to complete the Disposition section of the DPSEP Crime Log (Effective 11/1/2016)</i>	
<i>Active/Open Investigation</i>	The case is currently being investigated by the Department of Public Safety
<i>Unfounded</i>	The case is determined through investigation to be false or baseless. No offense occurred nor was attempted. Cases can only be unfounded by a sworn law enforcement agency.
<i>Closed: Forwarded to Department</i>	The case is referred to the appropriate department. They will review the case and determine if disciplinary action will be initiated.
<i>Closed: Forwarded to SLMPD</i>	The case is being investigated by the St. Louis Metropolitan PD
<i>Closed: Forwarded to Outside LE Agency</i>	The case is being investigated by a law enforcement agency other than SLMPD. The specific agency will be identified in the disposition.
<i>Closed: Forwarded to the Office of Student Responsibility and Community Standards(OSRCS)</i>	The case has been forwarded to OSRCS. This office is responsible for reviewing the case and for determining whether or not the student(s) involved will be charged with a violation(s) of the Student Code of Conduct
<i>Closed: Arrested</i>	Subject has been arrested by DPS, SLMPD or other area law enforcement
<i>Closed: Subject Issued No Trespass Letter</i>	The subject has been issued a University No Trespass Letter which restricts the subject from entering or accessing any university property. A violation may result in that person's arrest for trespassing.
<i>Closed: No suspects or witnesses</i>	Case has no solvability at this time.
<i>Closed- No Identifiable Suspect</i>	A description and/or video surveillance of the subject is available but positive identification of the subject has not been made.
<i>Closed- No further action is required</i>	No further investigative action is required.
<i>Closed- Reclassified</i>	The original incident report classification has been changed to accurately reflect the appropriate classification, based on the results of the investigation.
<i>*Closed: Received from OSRCS</i>	These are Clery crimes that were reported directly to the Office of Student Responsibility and Community Standard Office. These cases are reported to us during our monthly meeting and added to the crime log.
<i>**Closed: Criminal incidents reported by a Campus Security Authority (CSA) as part of Clery compliance</i>	These are Clery crimes that are reported by a CSA that occurred on our Clery geography and were not reported to DPSEP.
<i>***Closed: Criminal incidents reported by the LEA as part of Clery compliance</i>	These are Clery crimes that are reported by law enforcement agencies (LEA) that occurred in our Clery geography and were not reported to DPSEP.
<i>Closed: Forwarded to Title IX Coordinator</i>	This report was referred to the Title IX Coordinator for additional investigation.
<i>****Closed: Received from Title IX</i>	These are Clery crimes that were reported directly to the Title IX Coordinator. These cases are reported by the Title IX office and added to the crime log.
