

# Directions for Recording Agreements

For Instructors: Use the following directions when setting up a recording agreement in AccessPortal with students who have any kind of audio recording accommodation.

## **Step 1: Communicate with Students**


The student will need additional instructions before completing this agreement. Please let your students know:

- If there are times during the class that will contain sensitive discussions where recordings will need to be stopped and what indicator they will receive when it is time to do so (example, "Let's stop taking notes and stop any recordings and share our experiences.")
- What is your policy on sharing the recordings. The options on the agreement are:
  - Recordings must not be shared with anyone
  - Recordings may be shared with any students in the class
  - Recordings may be shared with anyone
  - Not Applicable
- What should the recording files be done with at the end of the quarter. The options on the agreement are:
  - Recordings must be destroyed
  - Recordings may be kept by the student
  - Instructor has no preference

## **Step 2: Student Enters Agreement**


After the course expectation has been established, the student needs to log into <u>AccessPortal</u>.

#### **Recording Agreement 2021**

I understand and agree that recording class proceedings for this course is permitted as an accommodation to me and that the sole purpose of the recording is to assist me in completion of course activities and requirements. Accordingly, I further understand and agree to the following conditions:

• Recording is limited to official class meetings and student-teacher conferences.

- The class will be notified that class sessions may be recorded without the instructor identifying me as the person recording. The instructor will maintain my confidentiality during this notification.
- The instructor may direct me not to record sensitive material that may be discussed in a given class session. The instructor will maintain my confidentiality when asking me not to record.
- I will not make copies of recorded material.
- I will not use the recorded material in any form for any purpose other than to accommodate my performance and learning in the course.
- At the end of the quarter, I will process all recordings as per my instructor's preference in the selections of this agreement.
- I will not share these recordings with anyone, unless otherwise specified by my instructor in the selections of this agreement.
- I have discussed this agreement with my instructor.
