Letter from the President:

Hello Union Siblings,

I hope everyone had a restful break. It has been a long year, and we have faced many challenges as education professionals. For our Clerical members, the clerical unit settled this fall, but the School Committee has pushed us into mediation as we fight for a Living Wage for our ESPS. They have spent this entire year working without a contract.

This battle is disappointing but not unfamiliar; we have learned the hard Haverhill lesson that contracts are not won in the negotiation room, but through large scale public campaigns. It is time for us to stand together and teach (review) the lesson once again. The public must be reminded of (1) the chronic underfunding of HPS schools, (2) the effect that has on our students and the services they need, and finally, (3) how the city values and pays their employees who do some of the hardest work for and with our students. We need YOU to spread the word, be vocal about this contractual disservice and if you would really like to lend your energy to the cause, please join us on the Action Team!

The BUDGET! The HEA will be at the front of the fight for a budget that puts students and staff first. We will demand real increases in municipal funding from Mayor Barrett this spring after the decades-long drastic underfunding we saw under the previous mayor. Working with other unions across the state, we will have to work to leverage for a state budget that increases Student Opportunity Act money and uses the Fair Share Amendment Money to help fulfill the legislation's promise to level the playing field for students like ours. There is state-wide strength and momentum in all of this- but we need your continued commitment and enthusiasm to win this fight.

If there is one thing I am sure that we as the HEA can do, it is stand up for what is right for our students, our families and ourselves. Though the upcoming months may be a fight, it is one that we will win together.

Rest in Peace Jean Ray. In 1976, Jean began her career in education, where she spent seven years teaching at Notre Dame Academy in Tyngsboro, MA, before returning to Haverhill Public Schools in 1983, following in the footsteps of her late mother, Alberta. Jean taught French, German, Latin, and Spanish at all four middle schools in Haverhill (JG Whittier, Nettle, Hunking, and Consentino) before returning to Haverhill High School, where she served as a Spanish teacher from 2003-2017. From 2010-2017, Jean spearheaded Read Across America

initiatives, often dressing as the Cat in the Hat to inspire a love of reading in young minds. Beyond the classroom, Jean was the heartbeat of Haverhill High School. Known for her genuine kindness and unwavering support, she played a pivotal role in students' lives, imparting valuable life lessons that ranged from the ordinary ("You catch more flies with honey than vinegar.") to the extraordinary ("Dogs do like to wear costumes!"). Whether solving last-minute prom crises, stepping in for parents on senior night, sitting front row at every graduation, or offering guidance, Jean touched the lives of many. She was a staunch supporter of the theater arts department, and could always be found in the audience of school plays, chorus, and band performances. As the Hillies' No. 1 sports fan, Jean attended every football, hockey, and basketball game with unwavering enthusiasm and minimal complaints about the weather. Her commitment to Hillies Athletics led the Haverhill High School hockey team to create an annual scholarship each year in Jean's name, and in 2008, Jean created a scholarship in memory of her late husband Dennis Ray.

In 2017, after more than 40 years of dedicated service, Jean retired from teaching, leaving behind a profound legacy. Her "farewell tour" as she referred to it, included reprising her Cat in the Hat role, visiting every kindergarten and elementary school to celebrate Read Across America Day. Her contributions were recognized with the 2017 Educator of the Year award by the YMCA of the North Shore.

Rest in Peace Julia Pennisi Taylor. who passed away peacefully at her home in October 2023. She is survived by her loving husband, Paul, with whom she shared 51 years of marriage, and their daughter, Julianne. Julia was a long term and consistent supporter of our HEA Scholarship and recently Paul established the "HEA Presents the Julia Pennisi Taylor Scholarship" to an HHS grad interested in pursuing Elementary Education. Julia was a dedicated and respected educator and reading specialist for 36 years in the Haverhill Public School system. She taught hundreds of children with reading challenges in several elementary schools throughout the district. Julia was a mentor to numerous teachers in the district as she truly believed in helping colleagues advance in their field. She had a special bond with a number of colleagues and maintained those friendships throughout her life. Julia retired in 2006 from Bradford Elementary School.

Rest in Peace Helen Henwood, who passed away in January 2024. Helen embarked on a long teaching career that included teaching both elementary and middle school at the Campbell School in Dracut, St. Michael's School in Lowell, and the Hunking Middle School. The HEA would like to recognize Helen's service to the union as 2nd VP for several years as well. From her Hunking and HEA colleague, Geoff Groskey, "Helen Henwood was a strong believer in people taking on personal responsibilities commensurate with their position. This applied to children, their families, and to our teaching staff as well. Her guidance toward that end was not only in the classroom, but in the teacher's room as well. Her voice was also strong as an advocate for educators, through her role as an officer of the HEA...it was through her efforts that I succeeded in that union role. We are no longer across the hall from each other but that connection was seemingly timeless. Thank you, Helen." KNOW YOUR WEINGARTEN RIGHTS

You have the right to union representation during investigatory interviews. According to the Supreme Court in NLRB v. J. Weingarten, Inc.

- 1. The employee must make a clear request for union representation before OR during the interview. The employee cannot be punished for making this request.
- After the employee makes the request, the <u>employer must</u> choose from among three options:
 - a. Grant the request and <u>delay the questioning</u> until the union representative arrives and has a chance to consult privately with the employee; OR
 - b. Deny the request and end the interview immediately; OR
 - c. Give the employee a choice between having the interview without representation (you should never choose this option!) or ending the interview.
- 3. If the employer denies the request for union representation and continues to ask questions, it commits an <u>unfair labor practice</u> and <u>the employee has a right to refuse to answer. The employer may not discipline the employee for such a refusal.</u>

When being interviewed by administration, if you feel the discussion could in anyway lead to disciplinary action invoke your Weingarten Rights by saying, "If this discussion could in anyway lead to my being disciplined or terminated, or affect my personal working conditions, I respectfully request that my union representative, officer, or steward be present at this meeting. Print out and keep this Weingarten Rights handy -

you never know when you might need it!
