Declare a Day Summer Contest Series Rules

1. **Eligibility:** No purchase necessary to enter or win the Giveaway. The Declare a Day Summer Contest Series promotion is open to legal residents of the 50 United States and D.C., who are at least eighteen (18) years of age as of May 2nd, 2023, except employees of Jackbox Games ("Sponsor") and its affiliates, partners, and advertising and promotion agencies, and anyone else involved in the development or execution of this Contest (collectively the foregoing entities are the "Contest Entities"), and the immediate families or household members of each. The contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited or restricted by law or regulations.
2. **How to Enter:** Entrants should submit their holiday proposal to the designated form posted on Jackbox Games social media channels (@playjackboxgames on Instagram and Tiktok and @jackboxgames on Twitter and Facebook) beginning at 11:00AM CT on May 2nd, 2023 through 11:59 PM CT on July 21st, 2023 ("Promotion Period"). This submission form will prompt entrants to give their name, email, social media handles, a description of what mundane event they want to celebrate (one to four sentences in length), and a photo or digital avatar of themselves to be used in promoting the holiday. Entrants may not disparage another individual, group, organization, or brand in their description or their entry will be void. Entrants must also agree to join the Jackbox Games email newsletter and agree to be tagged in social media on their designated holiday if selected. Each participant ("Entrant") may enter only one (1) time during the Promotion Period. In order to be eligible for a round, your entry must have been received before 11:00 AM CT two days before the Award Dates indicated below. Once you enter, you are eligible for all upcoming rounds through the end of the promotion.
3. **Prize:** Ten (10) Grand Prizes (that is, one per week listed below in Section 4): The weekly Grand Prize winners will each be awarded Steam codes for The Jackbox Party Packs 6-9 and a \$100 DoorDash gift card. Winners may not resell Steam codes won as prizes as part of this giveaway. Prize is non-transferable and no substitution by winners or cash equivalent is allowed. Sponsor reserves the right to substitute prize for one of equal or greater value if the advertised prize becomes unavailable. Winner is solely responsible for the payment of all federal, state and local taxes and all other expenses or costs relating to the prize not expressly set forth above.
4. **Selection of Winner:** On each Award Date, a Grand Prize winner will be selected from all eligible entries via a poll of Jackbox Games employees; provided that in the event of a tie amongst those getting the most votes, the winner will be selected randomly among those receiving the most votes. In order to win, entrants must have submitted all requested items (See Section 2: How to Enter) to the designated Google form shared on Jackbox Games social media channels during the Promotion Period. Sponsor's decisions are final and binding in all matters relating to this Contest. Winners will be notified via email with their prize and the date

5. **Release of Liability:** By participating, you release the Contest Entities and their respective employees from and against any and all injury, loss or damage caused or claimed to be caused by your participation in the Contest and/or the acceptance, awarding, receipt, use and/or misuse of the prize, and you agree that these entities and persons are in no way responsible for any warranty, representation, or guarantee, expressed or implied, in fact or in law, relating to the promotion and/or the awarding of any prize except as expressly set forth in these Official Rules. By participating in the Contest, you agree to be bound by these official rules, including all eligibility requirements. Failure to comply with these official rules may result in disqualification from the Contest. Sponsor reserves the right to: (i) permanently disqualify from any Contest it sponsors any person it believes has

intentionally violated these official rules; and (ii) suspend, modify or terminate the Contest if Sponsor believes, in its sole discretion, that malfunction, error, disruption or damage is impairing or will impair the administration, security, fairness, integrity or proper play of the Contest.

7. **Governing Law / Limitation of Liability.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Sponsor in connection with the Contest will be governed by and construed in accordance with the internal laws of the State of Illinois, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws. Any and all disputes, claims and causes of action arising out of or connected with this Contest or any prize awarded shall be resolved exclusively by the Federal or State courts located in Cook County, Illinois.

Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. Entrants agree to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Contest-related materials, privacy policy or terms of use on any Sponsor Website and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control.
