Parent Square Message sent out this fall

To help ensure a safe and enjoyable experience for everyone, the District would like to remind all spectators of the guidelines that must be followed when attending events at Knox Field:

- 1. No Bikes, Scooters, or Motorized Vehicles:** For safety reasons, bicycles, scooters, e-bikes, and motorized scooters are not permitted inside the fencing at Knox Field.
- 2. No Smoking/Alcohol:** No smoking, vaping, tobacco products, or alcohol will be allowed on any school grounds.
- 3. No Backpacks:** No backpacks are allowed; bags are subject to search.
- 4. Pets:** For the safety and comfort of all, pets and animals are not allowed on any school property unless they are service animals as defined by the Americans with Disabilities Act (ADA) or have special prior authorization from the Superintendent.
- 5. Knox Field Gate Access:** Please note that spectators must enter through the main entrance to Knox Field on South Perry Street.
- 6. Restricted Areas:** For safety reasons, the playground, tennis courts, and other field/open areas of Knox Field will be closed to the public during the game.
- 7. No Playing on the Hill:** The hill on the South Perry Street side is designated for seated spectators only. Please do not allow children to play on the hill, as it may pose safety risks and obstruct the view of others.
- 8. Student Supervision:** Students younger than eighth grade (or children younger than 13) are expected to have parent/guardian supervision at all times.
