- IF THE STUDENT DRIVES ANOTHER VEHICLE TO SCHOOL FOR WHATEVER REASON, SAID STUDENT IS RESPONSIBLE FOR NOTIFYING MR. MIGLIARO AT THE SECURITY DESK SO A TEMPORARY PASS CAN BE ISSUED FOR THAT VEHICLE OTHERWISE, A NO VALID PERMIT TICKET WILL BE ISSUED.
