### **INFORMATION ON THE PROCESSING OF PERSONAL DATA**

pursuant to Article 13 of Regulation (EU) 2016/679

Pursuant to Article 13 of Regulation (EU) 2016/679, we provide you with the following information:

#### **1. Who we are**

As the **Data Controller**, we pay the utmost attention to the security and confidentiality of our members' personal data.

#### **2. Which personal data we process and for what purposes**

We process:

- Name, surname, date and place of birth, tax code, address, and email;
- Sports medical certificate of fitness (for competitive and non-competitive activities).

The data are processed to comply with all legal requirements related to amateur sports associations, including:

- Registration in the members' register;
- Affiliation with the **Sports Promotion Body** of CONI (EPS) to which we belong – **ACSI Monza e Brianza**;
- Administrative management through the accounting firm **Mondo ASD**, directed by Dr. Fabrizio Gamba (Via Confalonieri, Monza);
- Convening of assemblies;
- Management of your participation in the association's sports and recreational activities, and in those organized by the EPS;
- Issuing receipts for fees and payments you have made.

Our association does **not** process "special categories of data," meaning any personal data revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, genetic or biometric data, data concerning health, or a person's sex life or sexual orientation.

#### **3. Legal basis for processing**

The processing of data is based on:

- Article 36 of the Italian Civil Code,
- The Association's Statute,
- Article 90 of Law 289/2002,
- Article 148 of the TUIR (Income Tax Code), paragraphs 3 and 8,
- Article 4(4) of DPR 633/1972,
- CONI and EPS regulations,
- Ministerial Decree of 18 February 1982 and Law 189/2012 (and subsequent amendments) regarding medical-sports certification,
- Article 15(1) of the TUIR.

#### **4. Obligation to provide data and consequences of refusal**

Providing the data referred to in point 2 is **mandatory**.

Failure to provide the requested data will make it impossible to establish or maintain membership in the association.

#### **5. Methods of processing**

Processing will be carried out as defined in Article 4(2) of the GDPR, namely:

collection, recording, organization, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, deletion, and destruction of data.

Processing will be performed using:

- Properly protected **electronic tools** (with antivirus, firewall, and regular backups);

- **Paper files** stored securely in locked premises, accessible only to authorized and properly trained staff.

#### **6. Retention period**

The association will retain personal data for as long as necessary to achieve the purposes listed in point 2, and in any case for no more than **10 years** from the date of collection, unless longer retention is required by law. After this period, data will be deleted or anonymized.

#### **7. Data recipients**

Data will be communicated **only** to:

- The Sports Promotion Body to which we are affiliated (**ACSI Monza e Brianza**),
- **CONI**,
- The accounting firm **Mondo ASD**,  
for administrative, membership, and organizational purposes connected with amateur sports activities as described in point 2.

#### **8. Data subject rights**

Pursuant to Articles 15–20 of Regulation (EU) 2016/679, you have the right to:

- Request confirmation of whether your personal data are being processed;
- Obtain information about the purposes of processing, retention periods, and recipients of your data;
- Object to or limit processing, and request rectification or erasure of data;
- Obtain data portability — i.e., receive your data from one controller in a structured, commonly used, machine-readable format and transmit them to another controller;
- Withdraw consent at any time without affecting the lawfulness of processing carried out before the withdrawal;
- Lodge a complaint with the **Italian Data Protection Authority (Garante per la protezione dei dati personali)** or another competent supervisory authority.

#### **9. Exercising your rights**

You may exercise the above rights by submitting a written request to the **Data Controller** via registered letter, certified email (PEC), or standard email.

Your request will be processed within **30 days** of receipt.

#### **10. Automated decision-making**

Your data will not be used in any automated decision-making or profiling process.
