1.1 The ‘Surface Operations Daybreakers Implementation’ (To be referred as ‘SODI’ for the duration of this document) is intended to describe the addition of the ‘Department of External Affairs’ within Site-65 to the aMTF Nu-7 (‘Hammer Down’) Squadron codenamed ‘Daybreakers’ (DB)

## Section I: Implementation of External Affairs

1.1 Members of the new 'Department of External Affairs' sub-squadron section of 'Daybreakers' will be expected to hold a professional and friendly attitude at all times, furthermore being expected to assist aMTF Nu-7 ('Hammer Down') in their day-to-day activities more often than the standard Department of External Affairs Field Agent. Furthermore, Field Agents are expected to follow the 'Daybreakers' rulebook within the authorized Handbook.

1.2 'Department of External Affairs' Field Agents within the 'Daybreakers' sub-squadron will take part in Top Secret operations assigned by the 'Daybreakers' OPCOM (Operations Command) Head Supervisors, along with standard aMTF Nu-7 ('Hammer Down') 'Daybreakers' operatives.

1.3 'Department of External Affairs' Field Agents within the 'Daybreakers' sub-squadron will utilize their enhanced utility items authorized to them by the Department Directors and Logistics to assist in 'Daybreakers' operations, specifically the 'Disguise Kits' and 'Spy Drone'. Furthermore, Field Agents may assist using their 'DSR-50' Marksman Rifles, 'M249 Para' Light Machine gun, 'Fang-45' Submachine Gun and 'Sticky Grenade' for the purpose of self-defense, sabotage and destruction of Hostile G.O.I (Group of Interest) property.

## Section II: Authorizations of D.E.A 'Daybreakers' Field Agents

1.1 'Department of External Affairs' Field Agents within the 'Daybreakers' sub-squadron will be granted access to aMTF Nu-7 ('Hammer Down') radio frequencies for the purpose of assisting the aMTF.

1.2 'Department of External Affairs' Field Agents within the 'Daybreakers' sub-squadron will be granted access to view the 'Daybreakers' external channels for the posting of information, new tactics and other 'Daybreakers' related information.

1.3 'Department of External Affairs' Field Agents within the 'Daybreakers' sub-squadron will be granted access to the 'Daybreakers' handbook for any required information they may need.

1.4 'Department of External Affairs' Managers within the 'Daybreakers' sub-squadron will be granted access to the sub-squadron's database for the purpose of management, addition of new Field Agents and any other required information.

## Section II: Ranking Structure

### Rank I: 'Field Agent' [DB]

Field Agents also known as 'Operatives' is the lowest rank within the 'Daybreakers' D.E.A sub-squadron, these are the newest members of the sub-squadron and will deal with front-line duties, they may be equipped with standard D.E.A Agent/Operative gear or standard D.E.A Senior Agent gear.

### Rank II: 'Liaison' [DB-DL]

Liaisons are the managers of Field Agents with the 'Daybreakers' sub-squadron, they may conduct disciplinary action on Field Agents not following the standard Code of Conduct of the 'Department of External Affairs'. These individuals will still deal with front-line duties but will typically be of a higher ranking within the 'Department of External Affairs', being around the rank of Special Agent or Agency Manager. These individuals may approve 'Department of External Affairs' Agents (in conjunction with aMTF Nu-7 'Daybreakers' Head Supervisors) and may remove Field Agents.

### Rank III: 'Manager' [DB-DM]

This is the leading member of the D.E.A 'Daybreakers' sub-squadron, and may appoint Liaisons with approval from aMTF Nu-7 'Daybreakers' Manager+. They may also remove Liaisons.
