PROXY INSTRUCTIONS

If you are unable to attend the annual membership meeting but still wish to be counted for quorum purposes as well as wish to appoint someone to vote on your behalf, you will need to appoint a proxy. Please note the following information about proxies:

1. A Board-approved General Proxy form is enclosed. Use this form to appoint another person to vote on your behalf in the event that you might not be able to attend the meeting and also to count your presence for the purpose of establishing a quorum at the meeting.

2. Please mail your proxy to First Service Residential or have it hand-delivered no later than registration prior to the start of the annual membership meeting. Note that, if you choose not to mail your proxy, it may be misplaced, lost, destroyed, or intentionally withheld by the person to whom you gave it.

3. If you appoint a proxy and later are able to attend the meeting in person, you may withdraw your proxy during registration.

4. A proxy may be revoked in writing or may be superseded by a later proxy to another person. It may also be assigned (or substituted) by the person designated on the proxy to a third person if the person you designate as proxy becomes unable to attend the meeting.

5. To be valid, a proxy must be dated, must state the date, time, and place of the meeting for which it was given, and must be signed by the authorized person who executed the proxy. A proxy is effective only for the specific meeting for which it was originally given, as the meeting may lawfully be adjourned and reconvened from time to time, and automatically expires 90 days after the date of the meeting for which it was originally given.
