1. Introduction

At Gemini Reader, protecting your privacy is our priority. This Privacy Policy describes how we collect, use, disclose, and safeguard information when you install and use the Gemini Reader browser extension.

2. Scope of This Policy

This policy applies solely to information obtained through your use of the Gemini Reader extensions for Chrome, Firefox, and Edge. It does not cover any other applications or services.

3. Business Model

Gemini Reader is 100% free to use. We do not sell, rent, or monetize your data. There are no paid tiers, in-extension ads, or hidden fees.

4. Information We Collect

4.1 User-Provided Feedback

- Bug Reports & Feedback: When you submit feedback through the extension's form, we collect the content of your message and your email address (if provided). This information is used only to troubleshoot and improve Gemini Reader.

4.2 Local Storage Data

We use your browser's extension storage API to store:

- Authentication State (isAuthenticated boolean)
- Overlay State (open/closed flag per origin: chat.openai.com or chat.com)
- Announcement IDs (to suppress already-seen notifications)

No other data is stored locally or transmitted elsewhere.

5. How We Use Your Information

- Improve the Extension: We process your feedback to fix bugs and enhance features.
- Maintain User Experience: Local storage flags enable seamless overlay behavior and announcement management across sessions.

6. Disclosure of Your Information

We do not share your feedback or local-storage data with third parties, except to comply with legal obligations or to protect the rights, property, or safety of Gemini Reader, its users, or others.

7. Data Security

- Feedback Storage: Submitted feedback is stored securely on a password-protected admin interface that is not publicly indexed or discoverable
- Local Storage Security: All browser-storage data remains on your device and is never sent to external servers (aside from feedback submissions).
- Built-in Extension Analytics: We rely on your browser's native extension analytics (which are given to all extension developers) and do not include any additional analytics, crash-reporting, or telemetry libraries.

8. Your Rights

Depending on your jurisdiction, you may have the right to:

- Access & Portability: Request a copy of the feedback you've submitted.
- Rectification: Ask us to correct any inaccurate feedback records.
- Erasure: Request that we delete your submitted feedback.
- Restrict or Object: Limit or object to our processing of your feedback.
