Scholarships are sorted by the month they are due, and are displayed on the scholarship bulletin located in the Counseling Center. **See the Scholarship Counselor if you have questions or need help with an application.** Give yourself plenty of time to complete the application process. **Make your best effort to not wait until the last minute to get letters of recommendation, transcripts, and essays together.** Transcripts must be requested two days in advance.
