**Whereas** East Bay DSA worked to coordinate this years Berkeley rent board convention to pick a slate of candidates to run for Berkeley rent board

**Whereas** The petitioner collected 25 signatures of current East Bay DSA members (15 in district)

Therefore be it resolved, East Bay DSA endorses the Berkeley rent board slate

# Resolution to unendorse Nikki Fortunato Bas for Supervisor Submitted by: Luca D., Andrew T.

**Whereas,** East Bay DSA endorsed Nikki Fortunato Bas for Alameda County Board of Supervisors District 5,

Whereas, on August 16, Nikki Fortunato Bas endorsed Jesse Arreguin for State Senate,

**Whereas,** Arreguin, speaking at an event held by the Jewish Community Relations Council (JCRC), a zionist lobby group that opposes "<u>any attempts to delegitimize Israel, including the BDS Movement</u>", pledged to not allow a ceasefire resolution to be passed by Berkeley City Council,

**Whereas,** Arreguin visited Israel on a JCRC-sponsored trip in 2022, departing the same day Palestinian journalist Shireen Abu Akleh was murdered,

**Whereas,** DSA member Jovanka Beckles, his opponent for State Senate, is the chapter endorsed candidate and is openly for Palestinian liberation and divestment,

**Whereas,** East Bay DSA passed the resolution <u>Organizing for Palestinian Liberation</u>, which requires that endorsed candidates "refrain from any and all affiliation with the Israeli government or Zionist lobby groups,"

**Whereas,** the resolution also states that endorsed candidates "upon receiving fair and ample opportunity for education about the Palestinian struggle for liberation, endorsed candidates who do not commit to the aforementioned basic expectations will have their EBDSA endorsement swiftly revoked,"

**Whereas**, the passage of the resolution signifies that many chapter members consider any enabling of Zionism or Zionist politicians to be an electoral red line for our organization,

**Whereas,** after being informed that Bas was considering endorsing Arreguin, the Steering Committee sent an email prior to her endorsement, asking her to reconsider, and advising her that — as a democratic organization — members may propose a resolution for her unendorsement on these grounds,

**Whereas**, to be a principled socialist in office requires that, at a bare minimum, you reject any possible action that would strengthen the position of Zionism locally

**Therefore, be it resolved,** East Bay DSA revokes its endorsement of Nikki Fortunato Bas effective immediately,

**Be it further resolved,** the Steering Committee will release a public statement on chapter social media explaining the political reasons behind the chapter's unendorsement.

# Resolution: Rebooting East Bay Majority into Bay Area Majority

Signees: Justin G; Zach W; Zoe S; Dani T; Simon B; Rane S.; Mitra Z; Jonathan M; Yari G; Charlotte A

Whereas: The East Bay DSA has become the largest and among the most active chapters in the Bay Area, touching on various areas of class struggle, and is thereby a feasible place to house a regional media organ;

Whereas: The bourgeois media rarely, if ever, reports on episodes of class struggle, be they labor, tenant, or movement happenings;

Whereas: The bourgeois media that does exists has become so consolidated, with fewer avenues for news and information about local politics and culture every year, and fewer viewpoints expressed across the media landscape;

Whereas: Proletarian culture has been largely neglected as a legitimate form of cultural production, and is rarely discussed unless it has become instrumentalized for profit-making, but the elevation of proletarian culture is an essential aspect of the class struggle because class consciousness requires a confident and socially validated class culture;

Whereas: East Bay Majority has significant potential to become an organ to class struggle, as a place of discourse that can amplify class struggle and give its participants their proper due, as well as a place where working-class culture can be discussed and elevated;

Whereas: Our organizing projects—be they new labor unions, rank and file work; tenant union work; or movement work like Palestine solidarity—would benefit from an organ that can property report on their happenings, as the words and images of our struggle must be represented, particularly within the current social media landscape;

Therefore, let it be resolved: *East Bay Majority* shall be rebooted, with its name changed to *Bay Area Majority*, in order to become the Bay Area's premiere place of class struggle news and proletarian cultural reportage;

Resolved: *Bay Area Majority* shall have an Editorial Board consisting of a minimum of three positions (and a maximum of five positions), and will have final say over what articles are published by *Majority*, only to be overruled by a majority vote of the chapter Steering Committee;

Resolved: Major topics of focus will be workplace organizing and labor struggles, tenant organizing, police repression, and working class arts and culture.

Resolved: The initial Editorial Board of *Majority* will consist of Zoe S, Charlotte A, and Justin G, with their first term coming to an end June 1, 2025.

Resolved: *Bay Area Majority*'s editorial board will be appointed by the EBDSA Steering Committee, and via majority Steering Committee vote. The Editorial Board will draft and maintain the editorial policy of *Majority* and present it (including any changes) to the chapter Steering Committee for approval;

Resolved: The chapter Steering Committee may add additional editorial positions to Bay Area Majority's Editorial Board;

Resolved: *Bay Area Majority* will solicit reportage on all class struggle episodes throughout the wider Bay Area, including happenings in Northern Central Valley if they are significant;

Resolved: *Bay Area Majority* will seek to integrate itself into the Bay Area culture, by maintaining an events calendar, and by hosting relevant public-facing events typically open to the public;

Resolved: *Bay Area Majority* shall not promote ideological writing on theoretical issues or internal DSA debates unless explicitly directed to do so by the Steering Committee;

Resolved: The East Bay DSA Steering Committee shall have the option to dedicate some EBDSA staff time for *Majority*-related matters, such as fundraising, editing, etc.;

Resolved: East Bay DSA shall initiate a *Majority* relaunch strategy that includes significant resources for fundraising, website revamping, reaching out to other DSA chapters to see if they are interested in contributing to this project, and any other preliminary or ongoing issues pertaining to the Bay Area Majority project.

Resolved: Eighty percent (80%) of all money raised explicitly for *Majority* (this amount can be changed by a majority vote of the chapter Steering Committee) will be reinvested in this project, with the top priority for funds going to paying writers for solicited stories and paying for translation of articles into Spanish, Chinese, and other languages spoken by working class people in the Bay Area. The rest of the funds will go directly to East Bay DSA for operational costs of maintaining such a project.
