- Superintendent's Report: Pandemic Learning Loss Funding, New Schools Construction Update, Summer School 2021, WRSD Summer Institute for Staff, Summer 2020 Maintenance Projects, Family Wellness Assistants, Minister's Youth Council, Ministers Teacher and Parent Advisory Council
- 2021 Health Guidelines for Schools
 - The board reviewed the 2021-2022 Health Guidelines for Schools. These documents have been provided by Alberta Education to school boards in the last two weeks. The provided summary included the evidence used to support the government's decisions for the discontinued mandatory health measures and the recommended best practices. The results from the survey sent to our school communities, was 78% in favour of adding no additional restrictions.
 - Several community members joined the meeting showing interest in this possible decision both in person and electronically. Delegates provided further insight into the advantages and disadvantages of implementing stricter Covid-19 protocols.
 - Roxanne Franczak provided a parental perspective from RMH, DV, Caroline and Corridor Schools. It was clear that the majority of parents do not wish to impose stricter covid protocols on their children. The well being of our children, including mental health is this group's first concern.
 - Dr. Chris Kendall is a family physician from Rocky Mountain House, with children attending WRSD. He spoke to the

- local status of Covid-19, including vaccination rates.
- Trustees shared their perspectives and had a discussion regarding the advantages and disadvantages of imposing stronger restrictions.
- Learning Services 2020-2021 Accountability Report
 - The Learning Services Coordinator presented the Accountability Report and shared the highlights from last year, which included our At-Home Learning program.
 - The board discussed that the requests for online learning may be higher than we anticipated, and what we can do to meet those needs. We will track the interest and see what the demands are.
