School Board Directors Present: Clayton Cargill, Eric Hewitt, via Zoom: Tim Sanborn, Molly Gleason

Absent: Dave Towle, Absent and Abstaining from discussion/vote. See below for explanation

School Administrators Present: Superintendent Matt Foster, via Zoom: Assistant Superintendent Mike Moriarty, Secondary Principal Natalie Conway, Elementary Principal Sarah Welch.

1. **Call meeting to order:** Clayton called the meeting to order at 5:30pm. Introductions were made around the room.
2. **Additions/Changes to the Agenda:** None
3. **Board Business**
 - 2024-26 ESP Contract (*Discussion/Proposed Ratification/Possible Approval*): Clayton presented the support services contract and highlighted the following:
 - It was a lengthy process and the intent was to increase wages to where they should be.
 - Union membership will be taken directly from paychecks rather than sent from the supervisory union
 - The days counted for a grievance procedure changed. School days are counted as grievance days.
 - The job description section has the most substantial changes. There are new contracts for specific employees, and the intent is to shift paraeducator positions to a career model rather than a temporary position and acknowledge the differences in similar positions such as a lead administrative assistant compared to an administrative assistant. Certain positions had to be created for special circumstances including the need for a deaf blind intervener.
 - Reviewed the steps and columns for positions and pay scale. Support staff can move columns to receive an increase in pay with training and experience.
 - The contract offers an additional personal day, and staff can sell back days at \$50/each to avoid the use of personal days at the end of the year to not lose the time.
 - Escalator to adjust pay for paraeducators to be substitutes and paraeducators moving up to another level so there is financial incentive to do it.
 - Contract includes this fiscal year which impacts the budget. Matt will share the amount of the increase with the board after the meeting.
