About the Award

The Outstanding Malayalee Community Organisation Award 2025 recognises the collective contributions of Malayalee community organisations that have made a positive and measurable impact in the areas of culture, arts, sports, and social development across New Zealand.

This award celebrates associations, clubs, or organisations that promote unity, cultural identity, and community service among Malayalees in New Zealand.

The award will be presented to the **President or Chair of the winning organisation** at **Malayalam FM's Mohanam 2026**, held on **21 February 2026** at the **Due Drop Events Centre, Auckland**.

Note: This award is being given to the association, club, or organisation, not to an individual. If there is a change in office-bearer positions at the time the award is distributed, the award will be presented to the President or Chair holding office during the year for which the award is being considered.

Terms and Conditions

1. Method of Submission

Nominations will be accepted only through the official Google Form available on Malayalam FM 104.6's verified platforms. Submissions by email, post, or any other means will not be considered.

2. Eligibility

The nominated entity must be a registered Malayalee community association, charity, sports or arts club, or other community or cultural organisation based in New Zealand. The organisation must have been actively operating for at least two (2) years as of 1 November 2025 and comply with all relevant New Zealand legal and registration requirements.

3. Who Can Nominate

Nominations must be submitted by the President, Chair, or an authorised office bearer or committee member of the organisation.

4. Authorisation Requirement

If the nominator is not the President or Chair, written authorisation from the President or Chair must be provided on the organisation's official letterhead. Nominations without proper authorisation will be rejected.

5. Nomination Limit

Only one nomination per organisation will be accepted. Multiple submissions from the same entity or breaching this rule will lead to disqualification.

6. Submission Deadline

Completed nominations must be submitted no later than **6:00 pm, Monday, 15 December 2025**. Late or incomplete submissions will not be accepted.

7. Nomination Requirements

All information provided must be accurate, complete, and verifiable. False, misleading, or unverifiable information will result in immediate disqualification. Supporting documents such

as registration proof, activity reports, or media references may be requested by the judging panel.

8. **Judging Process**

All eligible nominations will be reviewed by an independent judging panel appointed by Ideaweb Technologies Limited (T/A Malayalam FM 104.6). The judges may request additional information or clarification if required. The decision of the judges will be final and binding, and no correspondence will be entered into.

9. **Award Presentation**

The award will be presented to the President or Chair of the winning organisation at Malayalam FM's Mohanam 2026 on **21 February 2026** at the Due Drop Events Centre, Auckland. Malayalam FM 104.6 reserves the right to amend the date, venue, or format if necessary.

10. **Publicity and Consent**

By submitting a nomination, both the nominator and the nominated organisation consent to Malayalam FM 104.6 using their names, logos, photographs, and relevant details for promotional, media, and publicity purposes without further payment or approval. Malayalam FM may contact the organisation's representatives for verification or additional details.

11. **Disqualification**

Malayalam FM 104.6 reserves the right to disqualify any nomination that is incomplete, false, misleading, unverifiable, or breaches these Terms and Conditions or any applicable New Zealand law.

12. **Privacy Statement**

All personal and organisational information collected will be handled in accordance with the New Zealand Privacy Act 2020. Information will be used solely for administering and promoting this award and will not be shared with third parties without consent, except where required by law. 13. **General Disclaimer**

Submission of a nomination does not guarantee selection or receipt of an award. Malayalam FM 104.6 reserves the right to modify, postpone, or cancel the award process at its discretion. By participating, nominators and nominees agree to abide by these Terms and Conditions in full. The judges' decision will be final, and no correspondence will be entertained.
